5. Property Insurance. the excess, if any, paid to Borrower. Such insurance proceeds shall be applied in the order provided for in Section 2.

If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. 

#### (B) The Index

Beginning with the first Change Date, my interest rate will be based on an Index. Ine "Index" is the average of interbank offered rates for one-year U.S. dollar-denominated deposits in the London market ("LIBOR"), as published in The Wall Street Journal. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

#### (C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding Two And 65/100

#### (D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than

9.500 % or less than 4.500 %. Thereafter, my interest rate will never be increased or decreased on any single Change Date by more than Two And 00/100 percentage points from the rate of interest I have been paying for the preceding 12 months. #### (E) Effective Date of Changes
