NOW COMES the Plaintiff, the People of the State of Illinois, by and through their Attorney, Anita Alvarez, State's Attorney, of Cook County, through her Assistant, Lewis Hu, and states, upon information and belief, as follows:

- 1. That this cause of action arises under the provisions of 725 Illinois Compiled Statutes 150 and the provisions of Chapter 720 of the Illinois Compiled Statutes, Section 570/505(a)5, 570/505(a)6, 550/12(a)5, and 550/12(a)6 pertaining to violation or violations of the Controlled Substance Act and/or the Cannabis Control Act. and/or the Methamphetamine Control and Community Protections Act.
- 2. That there is within the jurisdiction of this Court, the following real property, located at 486 Sheridan Rd. #3, Evanston, Illinois, Cook, County, Illinois 60202

- 3. That the owner(s) of record of the above captioned property is Noah Seidenberg
- 4. That prior to October 19, 2011, Chicago Police were engaged in the investigation of cannabis trafficking by Noah Seidenber
- 5. That on or about October 19, 2011, Chicago Police Officers from the Organized Crime Division, Narcotics Section, gathered intelligence from a John Doe citizen that quantities of Cannabis were being sold out of a 3rd floor residence located at 486 Sheridan Road #3, Evanston, IL, by an individual named Noah Seidenberg (hereafter "Seidenberg"). John Doe indicated he has known Seidenberg for one year and that during that time period Seidenberg has always lived in the same residence at 486 Sheridan Road, #3, Evanston, IL 60602.
- 6. John Doe informed the police that on October 18, 2011, John Doe was in the residence of Seidenberg at 486 Sheridan Road #3, Evanston, IL in the front room area. At that time, John Doe stated that he saw Seidenberg in possession of a least five (5) pounds of Cannabis in which Seidenberg was bagging up at a table within the residence. John Doe further indicated that Seidenberg was cutting up a large quantity of Cannabis and placing the smaller quantity into plastic bags for individual sales.

- 7. John Doe further explained that the Cannabis that Seidenberg had in his residence was used to sale and distribute in the Chicago area. John Doe related that he has been in the presence of Seidenberg on numerous occasions when Seidenberg has talked about the illegal sales to other individuals. John Doe relates that while John Doe was in Seidenberg's residence, John Doe wanted to purchase an amount of Cannabis from Seidenberg.
- 8. John Doe and Seidenberg agreed on the price and Seidenberg removed a large clear plastic bag containing a green leafy substance from the table and handed it to John Doe. John Doe then took the plastic bag from Noah Seidenberg and opened the clear plastic bag and smelled the substance. John Doe stated the substance smelled like Cannabis. John Doe stated he left the residence and drove a short distance and parked his vehicle.
- 9. John Doe stated that he took some of the contents out of the plastic bag that John Doe had purchased from Seidenberg and placed the contents into a cigar wrapper and smoked the contents. John Doe stated that a short time later John Doe experienced the same high sensation that John Doe had received in the past from smoking Cannabis.
- 10. John Doe stated that before he left Seidenberg's residence, he still observed at least four (4) pounds of Cannabis on the table within Seidenberg's residence.
- 11. John Doe stated that John Doe has been using Cannabis for the past five years and had been purchasing Cannabis from Seidenberg for approximately one year. John Doe stated that whether it was day or night. Seidenberg has always satisfied John Doe with Cannabis.
- 12. The police and John Doe relocated to 486 Shericar Road, Evanston, IL at which time John Doe pointed to the third floor of a multi unit condo building. John Doe further related that the building and unit he had pointed out was the same building that John Doe was in when John Doe purchased the Cannabia from Seidenberg.
- 13. On October, 19, 2011, based upon the above facts, officers obtained search warrant #11SW8107, which was issued by a Judge of the Circuit Court of Cook County. The warrant was for Noah Seidenberg, and his residence at 486 Sheridan Road, Unit #3, a multi unit condo building, Evanston, Cook County, Illinois.
- 14. On October 19, 2011, at approximately 9:26 p.m., Chicago Police officers executed Search Warrant 11SW8107 at 486 Sheridan Road, Unit #3, Evanston, IL, 60202.
- 15. Upon executing the warrant, the team encountered the named target, Seidenberg and detained him. A systematic search of the condo revealed one (1) large bundle of a green leafy substance (suspect Cannabis) wrapped in a clear plastic garbage bag, twenty-one (21) large clear vacuum sealed bags each

containing a green leafy substance (suspect Cannabis), one (1) clear plastic ziploc bag containing a green crushed plant substance (suspect Cannabis), along with one (1) bundle of United States Currency totaling \$74,000.00 (pending official bank count) (the currency will be the subject matter of a separate forfeiture complaint).

- 16. The total amount of Cannabis recovered was 45,359 grams with an estimated street value of \$272,154.00.
- 17. The officers also recovered a Mead Five Star spiral notebook with name, dates, and numbers.
- 18. Scidenberg was placed into custody and read his Miranda rights. After being read his miranda rights and waiving said rights, Mr. Seidenberg stated to officers that the United States Currency recovered from his condo was profits from the sale of Cannabar.
- 19. Officers asked Seidenberg what was the nature of the spiral notebook with all the names and numbers in it. Seidenberg indicated that it was his customers for "weed".
- 20. Officers then questioned Seidenberg about the location of his vehicle at which time Seidenberg indicated that his vehicle was located in his gargage.
- 21. Once in the Homan Square police station, officers again read Seidenberg his Miranda rights at 11:59.p.m. After reading Seidenberg his Miranda rights and after Seidenberg waived said rights, Seidenberg voluntarily talked to the officers.
 - 22. Seidenber related that he sells "weed" to supplement his income.
- 23. Officers asked Seidenberg what kind of work at the do, Seidenberg indicated he was a real estate agent for Caldwell Banker.
- 24. Officers asked Seidenberg if he was having a difficult time selling real estate in today's difficult market. Seidenberg indicated that he has barely made any money in 2011 because people can't get financing or they back out of the deal at the last minute.
- 25. Seidenberg indicated that he made \$46,000 in 2010 and that the \$46,000 was the most money he had made in any of the eight (8) years that he has been selling real estate.
- 26. Officers asked Noah Seidenberg how long has he been dealing with his current supplier. Seidenberg indicated he has been using "Doug" for over ten (10) years.
- 27. Officers asked Seidenberg if he's been selling out of his current resident those ten (10) years. Noah Seidenberg indicated yes.

- 28. Officers asked Noah Seidenberg if his supplier delivers narcotics to his home or if he (Seidenberg) goes to his supplier's house to pick up his supply.
- 29. Seidenberg indicated that he did not want his neighbors to know his business, so he drive's to "Doug's" house to pick up his stuff.
- 30. Officers asked Noah Seidenberg if he picks up the narcotics from "Doug's" house and puts it in his 2007 Acura 4 door, V.I.N. 19UUA765X7A035158, license Plate: 6018781 IL, and then transports the narcotics to his residence at 486 Sheridan Road, Unit #3, Evanston, IL, 60202. Mr. Seidenberg responded, "yea".
- 31. Ciricers asked Seidenberg why did he keep the \$74,000.00 in his home instead of keeping it in a bank. Noah Seidenberg indicated he didn't want to mix his real estate earnings with the drug money.
- 32. During the interview with officers, Seidenberg communicated on a number of occasions that he could provide officers with information on his supplier if the officers would release him.
- 33. On October 20, 2011, at approximately 12:50 a.m., officers ordered a Canine unit to conduct a money line up on the recovered currency and to conduct a sniff on the vehicle for the presence of narcotics.
- 34. Canine Officer Valentine with capine "Raymond" responded to Homan Square for the sniff.
- 35. Canine "Raymond's" exterior search of the 2007 Acura 4 door, V.I.N. 19UUA765X7A035158, license plate 6018781IL revealed a positive hit to the trunk area of the vehicle for the presence of narcotics scent.
- 36. With regard to the \$74,000 that was recovered, officers secured a conference room on the 2nd floor of Homan Square. Office Valentine and canine "Raymond" cleared the room of any narcotics scent prior to the currency being placed in the room. Once the room was clear, officers hid the currency in the conference room. Officer Valentine re-entered the room with canine "Raymond" and gave him the command to search for dope. After his search, canine "Caymond" sat in front of the area where the money had been hidden which is an indication of a positive hit for the presence of narcotics scent.
- 38. A check of the Police Records revealed that Seidenberg has been previously arrested on September 9, 1976, by the Topeka Kansas Police Department for Possession of Cannabis with the intent to sell.
- 39. Based upon the training and experience of Chicago Police investigators, the above stated facts, the sale of cannabis from the defendant property, Seidenberg's admission that he has been selling cannabis for over 10 years from his residence, Seidenber's admission that he uses his vehicle to pick up cannabis from his supplier to bring to his home, Seidenber's admission that he sells cannabis from his residence to
