
SUBORDINATION AGREEMENT



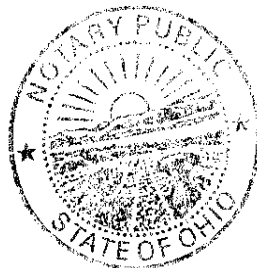
