

earthquakes and floous, from which Lender requires insurance, then: (i) Lender waives the provision in Section 3 for the Pariodic Payment to Lender of the yearly premium installments

provision in Section 3 for the Project Payment to Lender of the yearly premium installments for property insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.

What Lender requires as a condition of this waiver can change during the term of the loan. Borrower shall give Lender pompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.
