### **MEMORANDUM**

THIS MEMORANDUM is made by MDE THERMAL TECHNOLOGIES INC., an Illinois corporation (the "Supplier"), and GETCO, LLC, a Delaware limited liability company (the "Customer"). Reference is hereby made to that certain Chilled Water Service Agreement dated as of April 21, 2011 (the "Agreement") between Supplier and Customer, pursuant to which Supplier, at Customer's request, has agreed to provide certain chilled water service to a portion of the property commonly known as 350 North Orleans Street, Chicago, Illinois and legally described in the manner set forth on Exhibit A attached hereto (the "Property").

The purpose of this Memorandum is to provide notice of the Agreement and, in accordance therewith, Supplier and Customer hereby acknowledge and agree that (a) Customer has granted to Supplier a license (which is irrevocable except as expressly provided in the Agreement) to locate and install on the Property, in the location specified in the Agreement, an Energy Transfer System (as such term as hereafter defined), and has granted to Supplier a right of access to the System, and (b) notwithstanding the manner or method by which the Energy Transfer Station (as such term is hereinafter defined) is installed in the Property, (i) the Energy Transfer Station (or any part thereof) shall not be deemed to be a "fixture" attached to the Property subject to the lien of any mortgage or other encumbrance of the Property, and (ii) the Energy Transfer Station is the personal property of Supplier (subject to the term, and conditions of the Agreement) and is not to be deemed part of the collateral pledged to any londer or creditor of Customer as security for the repayment of any indebtedness of Customer.

As used herein, the term "Energy Transfer Station" shall mean the equipment and related piping and apparatus between Supplier's distribution piping and the Connection Equipment (as defined in the Agreement), including, without limitation, a plate frame heat exchanger assembly or equivalent device, piping, valves, metering equipment and controls and additional equipment, if any, described in the IOM Specifications (as defined in the Agreement) installed by Supplier on the Property pursuant to the terms of the Agreement for use in providing chilled water service to Customer, and all replacements and additions thereof.
