RECITALS

WHERE 15, the Board and the Owners desire to amend the Declaration to merge the 13934 Crestpoint Condom usum Association into the Crest Point Condominium Association.

WHEREAS, the Declaration Amendment has been executed by the Board of the Association and approved in writing by the acknowledged signatures of at least two-thirds (2/3) of the unit owners subject to the declaration, all in compliance with the declaration and the Illinois Condominium Property Act.

- (3) The members of 13934 Crest Point Condominium Association are no longer members of that Association but members of the Crest Point Condominium Association and bound by the terms, covenants and restrictions of the Declaration of Condominium Ownership for Crest Point Condominium Association.
