### **DECLARATION OF ABROGATION OF SETBACK LINES**

is made as of the 23 Kd day of Koronauton, 2011, by ALDI INC., an Illinois corporation ("Aldi"), 4600 SCHUBERT, LLC, an Illinois limited liability company ("4600") and KLAIRMONT FAMILY ASSOCIATES, L.P., an Illinois limited partnership ("Klairmont"). Aldi, 4600 and Klairmont are sometimes collectively hereinafter referred to as "Owners").

### WITNESSETH:

WHEREAS, Aldi is the fee simple owner of the real property legally described in Exhibit "A," which is attached hereto and made a part hereof (in "Aldi Property"); and

WHEREAS, 4600 is the fee simple owner of the real property legally described in Exhibit "B," which is attached hereto and made a part hereof (the "460" Property"); and

WHEREAS, Klairmont is the fee simple owner of the real property legally described in Exhibit "C," which is attached hereto and made a part hereof (the "Klairmont Property"). The Aldi Property, the 4600 Property and the Klairmont Property are sometimes collectively referred to herein as the "Property"); and

WHEREAS, the Property is subject to certain setback lines as contained in the Certificate of the Plat of Subdivision of the S.S. Hayes Kelvyn Grove Addition, which was recorded with the Office of the Cook County Recorder of Deeds on September 10, 1873 as Document 125133 (the "Subdivision") which include a fifteen foot (15') setback line south of and parallel to the south line of West Diversey Avenue along the north line of the Klairmont Property (the "15 Foot Diversey Setback") and a thirty foot (30') setback line north of and roughly parallel with the north line of portions of vacated and to-be-vacated Parker Avenue (the "30 Foot Parker Setback"; the 15 Foot Diversey Setback and the 30 Foot Parker Setback are sometimes referred to collectively herein as the "Setbacks"); and

WHEREAS, Aldi, 4600 and Klairmont are the fee simple title owners of all of the lots located within the Subdivision; and

WHEREAS, the Owners desire to declare for themselves and their successors and/or assigns that the Setbacks are hereby abrogated, released, vacated and cancelled, all as set forth in this Abrogation.

NOW, THEREFORE, in consideration of Ten and NO/100 Dollars (\$10.00), and other good and valuable considerations, the receipt, sufficiency and adequacy of which are hereby acknowledged, the Owner covenants and agrees as follows:

- 1. <u>Kecitals</u>. The recitals set forth above are incorporated into this Abrogation and shall be deemed terms and provisions hereof, the same as if fully set forth in this Paragraph 1.
- 2. <u>Abrogation</u> The 30 Foot Parker Setback and the 15 Foot Diversey Setback, both as described above, are hereby abrogated, released, vacated and cancelled.
- 3. <u>Binding</u>. This Abregation shall be binding upon and shall be for the benefit of the lands burdened by the Setbacks prior to the execution hereof.
- 4. <u>Counterparts</u>. This Abrogation may be executed by the parties in counterparts, which when taken together, shall constitute on agreement.
