## PLAT OF SURVEY

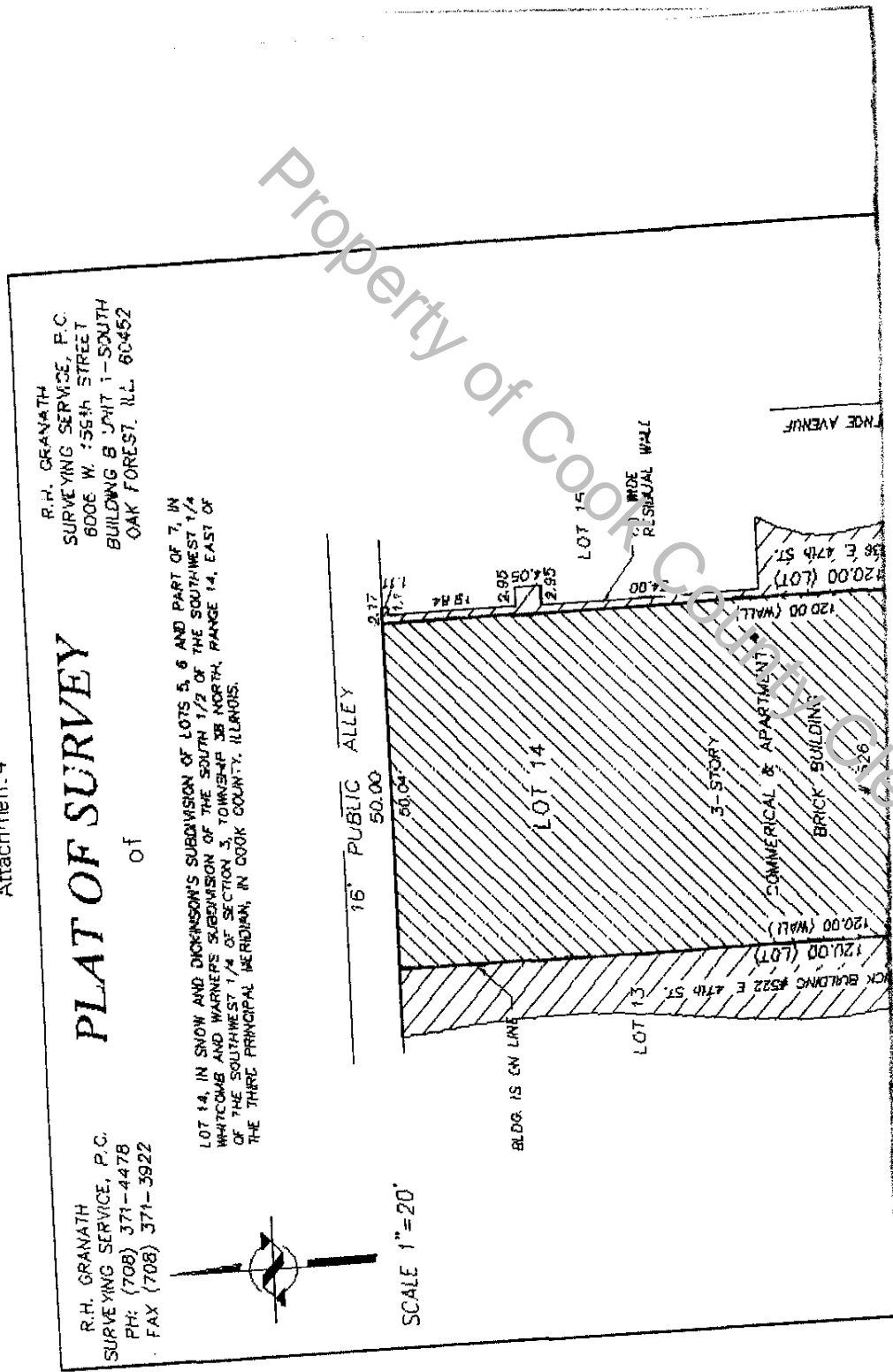
