This cause coming to be heard on Plaintiff's motion to Void the Selling Officer's Deed, due notice having been given and the court being fully advised in the premises;

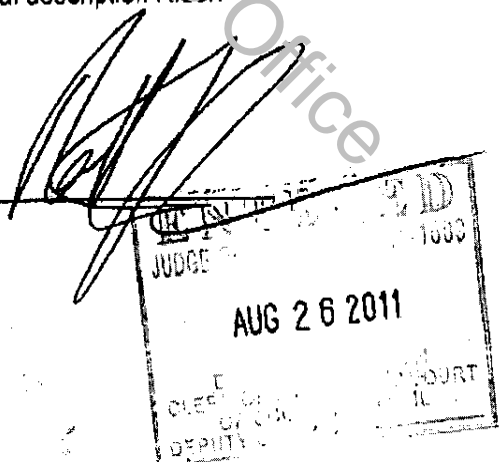


