ORDER

THIS CAUSE coming on to be heard on Plaintiff's Motion for Summary Judgment, as Amended, all parties having due notice and the court being fully advised in the premises:

IT IS HEREBY FOUND as follows:

- a. That on December 14, 2011, this court entered Summary Judgment in favor of the Plaintiff, Sysco Chicago, Inc., and against the Defendant, Keith E. Wolick.
- B That Defendant, Grand Bear Lodge, LLC, is in bankruptcy.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff, Sysco Chicago, Inc., have and recover judgment against Defendant Keith E. Wolick in a principal amount of \$80,654.06, plus interest at the rate of 18% per annum from February 9, 2009 through December 15, 2011 in the amount of \$41,325.18, for a total of \$121,979.88.

IT IS FURTHER ORDERED that Plaintiff have and recover attorneys' fees in the amount of \$350.00, making a total final judgment in favor of the Plaintiff and against the Defendant, Keith E. Wolick, in the sum of \$122,329.88 plus court costs.

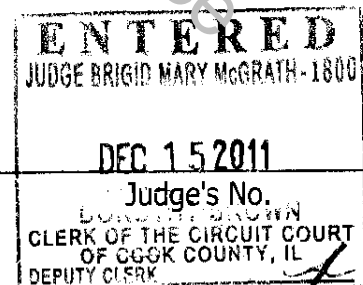
IT IS FURTHER FOUND that this is a final judgment, and there is no just cause to delay enforcement or appeal of this judgment.
