- 3. The Court having heard testimony and evidence finds that the building located on the subject property is dangerous, hazardous, unsafe and beyond reasonable repair under the Unsafe Buildings Statute, 65 ILCS 5/11-31-1 (1996) in that:
- a. The front building's southeast wall is cracked and leaning with open mortar joints as well as loose and missing bricks.
- b. The front building's parapet wall is bowed.
- c. The front building's coping is damaged at the east and west elevations.
- d. The front building's chimney has loose and missing bricks.
- e. The front building's roof and eaves are damaged, with missing sheathing and flashing.
- f. There are open mortar joints at the front building's foundation wall.
- g. The front building's window glazing's broken.
- h. The front building is marked with graffith
- i. The rear building's glazing is cracked, broken or rusting.
- j. The rear building's heating system is stripped or inoperable, and the furnace is missing.
- k. The rear building's masonry is missing sections and partially collepsed.
- 1. The rear building's masonry has washed out mortar joints and evidence of step or stress fractures at all four corners.
- m. The rear building's plaster is broken or missing.
- n. The rear building's plumbing is stripped or inoperable with missing fixtures.
- o. The rear building's truss cords are sagging.
- p. The rear building's roof is water damaged with a damaged membrane.
- q. The rear building's roof sashes are water damaged and broken.

- r. The rear building's stairs are missing handrails.
  - 4. Demolition of the subject property, as a whole, is the least restrictive alternative available to effectively abate the conditions now existing there.

#### WHEREFORE, IT IS HEREBY ORDERED THAT:

- A. Judgment is entered in favor of Plaintiff City of Chicago and against Defendants on Counts I and IV of the City of Chicago's complaint for demolition.
- B. The remaining counts of the City's complaint for demolition are voluntarily dismissed.
- C. Pursuant to 65 ILCS 5/11-31-1 and the City's police powers under Article VII of the Illinois Constitution, the City is granted authorization to demolish the building on the subject property, effective intraclately and is entitled to a lien for the costs of demolition, court costs, and other costs enumerated by statute, and/or other statutory remedies.
- D. Defendants shall errove any and all persons, if any, occupying the subject property and all personal property from said premises no later than the effective date so that said premises will be completely vacant and free of personal property before demolition is commenced.
- E. Pursuant to Illinois Supreme Court Rule 304(a), this is a final and appealable order. The Court finds no just reason for delay in the enforcement or appeal of this order.

F. The Court reserves jurisdiction of this cause to enforce the terms of this order and for the purpose of ascertaining and approving the demolition and litigation costs.
