## FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR THE 1630-32 W. DIVERSEY CONDOMINIUM

THIS DECLARATION, made and entered into this  $\frac{10}{10}$  day of September 2011 by PADRAIC HENEGRIAN (Owner of Unit 3W and P-3W); and JAMES D. FEREA and ROBERT C. KRAMP (Owners of Unit 1W and P-1W) (herein collectively referred to as "Owners") being owners with an interest in Parking Space P-3W and Parking Space P-1W at the 1630-32 W. Diversey Condominium.

#### WITNESSETH

WHEREAS, by the Declaration of Condominium Ownership recorded in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 1035529060 (the "Declaration"), Declarant submitted the real estate legally described in Exhibit "A" to the Declaration (the "Parcel") to the Condominium Property Act of the State of Illinois (the "Act"), said condominium being known as The 1630-32 W. Diversey Condominium (hereinafter referred to as the "Condominium"); and

WHEREAS, the Owners desire to amend the survey attached as Exhibit "D" to the Declaration to modify the locations of Parking Spaces P-1W and P-3W; and

WHEREAS, the other unit owners do not have an interest in Parking Spaces P-1W and P-3W:

WHEREAS, a modification of the location of the aforementioned parking spaces will not affect any property rights of the other unit owners;

WHEREAS, pursuant to the Declaration and the Condominium Property Act, the Owners have the right to amend said Declaration.

NOW THEREFORE, Owners for the purposes above set forth, hereby declare that the Declaration be and hereby is amended as follows:

- The survey attached as Exhibit "D" to the Declaration identifies the Parking Spaces as follows:
  - Parking Space P-3W is identified as the easternmost parking space; A. and
  - B. Parking Space P-1W is identified as the space two spaces west of the easternmost parking space.
- The survey attached as Exhibit "D" to the Declaration is hereby amended and superseded by the substitution of the survey attached, switching the location of Parking Space P-1W to the location currently identified a Parking Space P-3W; hereto identifying the Parking Spaces as follows:
  - Parking Space P-1W is identified as the easternmost parking space; and
  - Parking Space 2-3W is identified as the space two spaces west of the B. easternmost parking space.
- Except as expressly set for the herein, the Declaration and all exhibits thereto 3. shall remain in full force and effect in accordance with its terms.
