Together with the tenements and appurtenances thereunto belonging

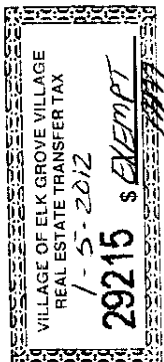
To Have and to Hold the same unto said party of the second part, and to proper use, benefit and behoof forever of said parties of the second part.

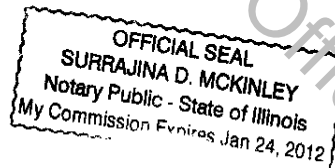




