#### **DURABLE POWER OF ATTORNEY FOR PROPERTY**

POWER OF ATTORNEY made this 10th day of August, 2009.

NOTICE: THE PURPOSE OF THIS POWER OF ATTORNEY IS TO GIVE THE PERSON YOU DESIGNATE (YOUR "AGENT") BROAD POWERS TO HANDLE YOUR PROPERTY, WHICH MAY INCLUDE POWERS TO PLEDGE, SCOLOR OTHERWISE DISPOSE OF ANY REAL OR PERSONAL PROPERTY WITHOUT ADVANCE NOTICE TO YOU OR APPROVAL BY YOU. 3. In addition to the powers granted above, I grant my agent the following powers (here you may add any other delegable powers including, without limitation, power to make gifts, exercise powers of appointment, name or change beneficiaries or joint tenants or revoke or amend any trust specifically referred to below):

To disclaim any and all property interests, including, but not limited to, any interests in tax qualified plans and individual retirement accounts.

To act on behalf of the principal with respect to any interests held in joint tenancy.

To make gifts to my children and their spouses, and my grandchildren and their spouses, in the amount of the annual gift tax exclusion for federal estate tax purposes.
