- C. Transfer of limited common element Storage Space L.C.E. 2200-3:
 - 1. The Declarant is the legal owner of limited common element Storage Space L.C.E. 2200-3. The Declarant has not yet assigned limited common element Storage Space L.C.E. 2200-3 to any Unit in the Association.
 - 2. Leavitt Group is the legal owner of Unit 713.
 - 3. Declarant is desirous of assigning limited common element Storage Space L.C.E. 2200-3 to be appurtenant to Unit 713 owned by Leavitt Group, and Leavitt Group is desirous of affecting such assignment.
 - 4. Such a transfer is permitted pursuant to Section 26 of the Act and Section 3.4 of the Declaration.
