In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

1. As of September 1st, 2011 , he amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$311,423.4", consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest and other amounts capitalized.

Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance for the first three years at the yearly rate of 7.125% from September 1st, 2011, and Borrower promises to pay monthly payments of principal and interest in the amount of U.S. \$2,350.39, beginning on the 1st day of October, 2011. During the fourth year and continuing thereafter until the Maturity Date (as hereinafter defined), interest will be charged at the yearly rate of 9.400% from September 1st, 2014, and Borrower shall pay monthly payments of principal and interest in the amount of U.S. \$2,759.17, beginning on the 1st day of October, 2014 and shall continue the monthly payments thereafter on the same day of each succeeding month until principal and interest are paid in full. If on June 150,2033, (the "Maturity Date"), Borrower still owes amounts under the Note and Security Instrument, as amended by this Agreement, Borrower will pay these amounts in full on the Maturity Date.

If all or any part of the Property or any interest in the Property is sold or transferred (or if Borrower is not a natural person and a beneficial interest in Borrower is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by the Security Instrument.

If Lender exercises this option, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Borrower must pay all sums secured by the Security Instrument. If Borrower fails to pay these sums prior to the expiration of this period, Lender may invoke any remedies permitted by the Security Instrument without further notice or demand on Borrower.

- Borrower also will comply with all other covenants, agreements, and requirements of the Security 4. Instrument, including without limitation, the Borrower's covenants and agreements to make all payments of taxes, insurance premidins, assessments, escrow items, impounds, and all other payments that Borrower is obligated to make under the Security Instrument; however, the following terms and provisions are forever canceled, null and void, as of the specified date in paragraph No. 1 above:

By executing this Agreement, Borrower waives any Timely Tayment Rewards rate reduction to which Borrower may have otherwise been entitled; and
- all terms and provisions of any adjustable rate rider, or Timely Payment Rewards Rider, where applicable, or other instrument or document that is affixed to, wholly or partially incorporated into, or is part of, the Note or Security Instrument and that contains any such terms and provisions as those referred to in (a) above.

- All the rights and remedies, stipula ions, and conditions contained in the Security Instrument (a) relating to default in the making of payments under the Secu ity Instrument shall also apply to default in the making of the modified payments hereunder.
