SUBORDINATION AGREEMENT



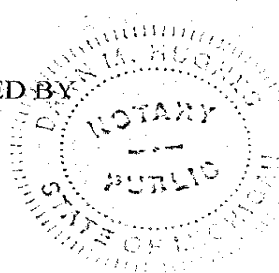
