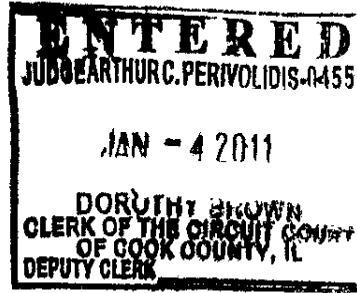

ORDER

This cause having come on to be heard pursuant to mediation undertaken by and between Eve Piechuta as guardian of the estate of Dorothy Piechuta, a disabled person now deceased, which is captioned in Cook County at 07 P 7113 and Gabriel Kostecki, an attorney who represented Eve Piechuta in those proceedings and who filed a fee petition relating to his representation which was disputed by Eve Piechuta, the parties having reached a settlement of the fee petition in the presence of the Court and with the direct assistance of the Court, and the Court confirming the specific terms and conditions settled upon which are specifically listed hereunder,

IT IS HEREBY ORDERED THAT:

1. In exchange for the full and final settlement amount of \$25,000 to the order of Gabriel Kostecki, consideration of which is tendered in open Court as draft # 1044 dated 01-04-2011 and drawn on US BANK, the pending fee petition of Gabriel Kostecki is dismissed with prejudice. Attorney Adam Augustynski shall mail by US Express Mail the original \$25,000 check to the office of attorney Kostecki at 5850 N. Milwaukee, Chicago, IL 60646 within two business days of the date of this Order.
2. Gabriel Kostecki withdraws with prejudice his petition for letters of office in this cause.
3. This Honorable Court retains jurisdiction over the parties hereto and the subject matter hereof for purposes of enforcement of this Order and of each and every term and condition thereof.
