POWER OF ATTORNEY

 - (iii) to execute and deliver and take any action of whatever kind and nature as may be necessary or proper in the exercise of the rights and powers herein granted, with full powers of substitution and revocation.
- (b) I do hereby give and grant to my Attorney full power and authority to do and perform all and every act, deed and thing whatsoever in and about my estate, property and affairs, as fully and effectually and to all intents and purposes as I might or could do in my own proper person, if personally present and acting, the above specially enumerated powers

- 6. Reliance By Third Parties. No person or organization dealing with my Attorney shall be required to see to the application of any money or property paid or delivered to my Attorney.
- 1. Indemnification of Attorney. My Attorney shall not at any time be held liable for any action taken or not taken or for any loss or depreciation in the value of any property, whether due to an error of judgment or otherwise, where my Attorney has exercised good faith in the exercise of his duties. My Attorney shall be proved by affirmative evidence. My Attorney shall not be personally liable on any obligation of mine. I hereby agree to indemnify and hold harmless each of my Attorney from any loss arising out of any action, suit or proceeding, either actual or threatened, in which my Attorney has been made a party (or has been threatened to be made a party) by reason of the fact that he is or was my Attorney hereunder, and I hereby bind myself, my heirs, devises, and personal representatives to indemnify my Attorney against any and all expenses (including attorneys' fees) actually and reasonably incurred by my Attorney in connection therewith. The preceding sentence shall not in any manner limit, contravene or restrict the rights to reimbursement to which my Attorney would otherwise be entitled as a matter of law.
