The above mentioned Aboriginal is a U.S. National according to USC 8 Section 1401(b).

All applicable treaties between the Indigenous Nations and the United States of America are applicable.

Indigenous National Nyeema Bey is protected under International Law United Nations Declaration on the

Rights of Indigenous Peoples (Article 6) – Every Indigenous individual has a right to a nationality, United Nations Declaration of Human Rights (Article 15) (1) – Everyone has the right to a nationality (2) No one shall be arbitrarily deprived nor denied the right to change his nationality

The above action is not made to defraud anyone or to violate any laws applicable to Indigenous Americans and is made to remedy the genocidal acts and acts of denationalization against the political identity of the Indigenous herein.

The Indigenous National Nyeema Bey is an Indigenous National of the International Indigenous Society (ISIS) and Aboriginal Republic of North America Government, an Indigenous Government operating an Indigenous Plebiscite which has been noticed to and confirmed by the United States Department of States (Federal Authentication # 060131441) signed by Secretary of State Condoleezza Rice and in conformity with 22 CFR 131.1 & 131.2, USC Title 4 section 42 and is protected/governed by International Law United Nations Declaration on the Rights of Indigenous Peoples (Article 4) – Self Autonomy Government

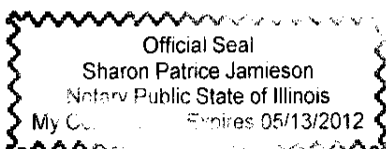

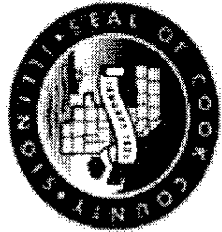

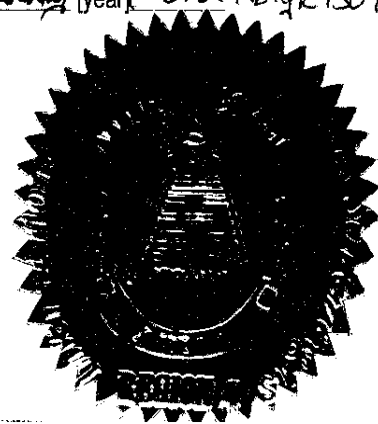
