
## SUBORDINATION AGREEMENT

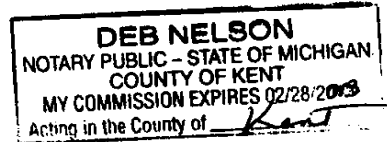
