THIS MATTER coming to be heard upon the Complaint of Plaintiff, Florida Financial Group, LLC ("FFG") against Defendant, Christopher Feurer and Kristen Stojentin Feurer, (the "Feurers"), the parties consent to the entry of this Order and the Court being fully advised in the premises, enters the following findings and Order:

1. This Court has jurisdiction over the subject matter herein and the parties hereto.
2. Pursuant to the promissory note executed by Feurer on September 10, 2007, which was subsequently amended and restated on September 10, 2008, and which was later assigned to FFG on December 21, 2010, the parties agree that \$518,246.58 is due from the Feurers to FFG.

- A. That Plaintiff, FFG, recover from Defendants, the Feurers, damages in the amount of \$518,246.58;
- B. Judgment for FFG in the amount of \$518,246.58 is hereby entered;
