The parties to this Mortgage, made as of October 25, 2011 are KINGDOM BUILDING MISSIONARY BAPTIST CHURCH, an Tilinois Not For Profit Corporation (Mortgagor); and G.B. Property Management Inc. ("Mortgage:").

I Grant and Secured Obligations

- Obligations defined a described in Section 1.2, Mortgagor hereby irrevocably and unconditionally grants, conveys, mortgages and warrants to Mortgagee, with right of entry and possession, all estate, right title and interest which Mortgagor now pas or may later acquire in and to the following property (all or any part of such property, or any interest in all or any part of it, as the context may require, the "**Property**"):
- (a) the real property commonly known as 7427 S. Ashland Aver ue, Chicago, Illinois and as such property is legally described in **Exhibit A**, together with all existing and future easements and rights affording access to it (the "Land"); together with
- (b) all buildings, structures and improvements now located or later to be constructed on th Land (the "Improvements"); together with
- (c) all existing and future appurtenances, privileges, easements, franchises and tenements of the Land, including all minerals, oil, gas other hydrocarbons and associated substances, sulphur, nitrogen, carbon dioxide, helium and other commercially valuable substances which may be in, under or produced from any part of the Land, all development rights and credits, air rights, water, water rights (whether riparian, appropriative or otherwise, and

whether or not appurtenant) and water stock, and any land lying in the streets, roads or avenues, open or proposed, in front or adjoining the Land and Improvements; together with

- (d) all existing and future leases, subleases, subtenancies, licenses, occupancy agreements and concessions ("leases") relating to the use and enjoyment of all or any part of the Land Improvements, and any and all guaranties and other agreements relating to or made in connection with any of such leases; together with

Including all pumping plants, engines, pipes, ditches and flumes, and also all gas electric, cooking, heating, cooling, air conditioning, lighting, refrigeration and plumbing fixtures and equipment, all of which shall be considered to the fullest extent of the law to be real property for prop
- (g) All building materials, equipment, work in process or other personal property of any kind, whether stored on the Land or elsewhere, which have been or later will be acquired for the purpose of bing delivered to, incorporated into or installed in or about the Land or Improvements; together with
- (h) All of Mortgagor's interest in and to the Loan funds, whether disbursed or not, and Mortgagor's own funds now or later to be held on deposit with the Mortgagee under the Loan Agreement (described in Section 1.2(a)(iii) hereof), and any other bank accounts of Mortgagor; together with
- (I) Any and all other existing and future transactions between Mortgagor and Mortgagee or any other party which may afford interest rate protection to all or part of the Loan; together with
- deferred payments, refunds, cost savings, payments and deposits, whether now or later to be received from third parties (including all earnest money sales deposits) or deposited by Mortgagor with third parties (including all utility deposits), contract tights, development and use rights, governmental permits and licenses, applications, architectural and engineering plans, specifications and drawings, as-built drawings, chattel paper, instruments, documents, notes, drafts and letters of credit (other than letters of credit in favor of Mortgagee), which arise from or relate to construction on the Land or to any business now or later to be conducted on it, or to the

- (k) All proceeds, including all claims to and demands for them, or the voluntary or involuntary conversion of any of the Land, Improvements or the other property described above into cash or liquidated claims, including proceeds of all present and future fire, hazard or casualty insurance policies and all condemnation awards or payments now or later to be made by any public body or decree by any court of competent jurisdiction for any taking or in connection with any condemnation or eminent domain proceeding, and all causes of action and their proceeds for any damage or injury to he Land, Improvements or the other property described above or any part of them, or breach or warranty in connection with the construction of the Improvements, including causes of action arising tin tort, contract, fraud or concealment of a material fact; together with

1.2 Secured Obligations.

- (a) Mortgagor makes the grant, conveyance and mortgage set forth in Section 1.1 and grants the security interest set forth in Article III for the pu pose of securing the following obligations(the "Secured Obligations") in any order of priority that Mortgagee may choose:
 - (i) Payment of all obligations at any time owing under cor'ain promissory notes secured by this mortgage (the "Note") bearing the several dates, payable by Mortgagor, and guaranteed by others, as maker in the total stated principal amount of Tylenty Thousand Dollars and no/00 (\$20,000.00) to the order of Mortgagee; and
 - (ii) Payment and performance of all obligations of Mortgagor under this Mortgage; and
 - (iii) Payment and performance of any obligation or Mortgagor under any Loan Documents which are executed by Mortgagor; and
 - (iv) Payment and performance of all obligations of Mortgagor arising from any and all existing and future agreements and transactions with Mortgagee which may afford

interest rate protection to all or part of the Loan, when a writing evidences the parties' agreement that the obligations be secured by this Mortgage; and

- (v) Payment and performance of all future advances and other obligations that Mortgagor or any successor in ownership of all or part of the Property may agree to pay and/or perform(whether as principal, surety or guarantor) for the benefit of Mortgagee, when a writing evidences the parties' agreement that the advance or obligation be secured by this Mortgage; and
- (vi) Payment and performance of all modifications, amendments, extension, and renewals, however evidenced, of any of the Secured Obligations.
- Property will be considered to have notice of, and will be bound by, the terms of the Secured Obligations and each other agreements or instrument made or entered into in connection with each of the Secured Obligations. These terms include any provisions, if any, in the Note or the Loan Agreement which permit borrowing, repayment and reborrowing, or which provide that the interest rate on one or more of the Secured Obligations may vary from time to time.

II. Assignments of Rents.

- Assignment. Subject to the License granted to Mortgagor under Section 2.2 hereof, Mortgagor hereby assigns to Mortgagee all rents, royalties, issues, profits, revenue, income, accounts, proceeds and other benefits of the Property, whether now due, past sue or to become due, including all prepaid rents and security deposits (some or all collectively, as the context may require, "Rents"). This is an assignment for security only.
- 2.2 <u>Grant of License.</u> Mortgagee hereby confers upon Mortgagor a license ("**License**") to collect and retain the Rents as they become due and payable, so long as no Event of Default, as defined in Section 6.2, shall exist and be continuing. If an Event of Default has occurred and is continuing, Mortgagee shall have the right, which it may choose to exercise in its sole discretion, to terminate this License without notice to or demand upon Mortgagor, and without regard to the adequacy of Mortgagee's security under this Mortgage.
- 2.3 <u>Collection and Application of Rents.</u> Subject to the License granted to Nortgagor under Section 2.2, Mortgagee has the right, power and authority to collect any and all Rents. Mortgagor hereby appoints Mortgagee its attorney-in-fact to perform any and all of the following acts, if and at the times when Mortgagee in its sole discretion may so choose:
 - (a) demand, receive and enforce payment of any and all Rents; or
 - (b) give receipts, releases and satisfactions for any and all Rents; or

(c) sue either in the name of Mortgagor or in the name of Mortgagee for any and all Rents.

Mortgagee's right to the Rents does not depend on whether or not Mortgagee takes possession of the Property as permitted under subsection 6.3[c). In Mortgagee's sole discretion, it may choose to collect Rents either with or without taking possession of the Property. Mortgagee shall apply all rents collected by it in a manner provided under Section 6.6. If an Event of Default occurs while Mortgagee is in possession of all or part of the Property and is collecting and applying Rents as permitted under this Mortgage and any receiver shall nevertheless be entitled to exercise and invoke every right and remedy afforded any of them under this Mortgage and at law or in equity.

- 2.4 <u>Mortgagee Not Responsible.</u> Under no circumstances shall Mortgagee have any duty to produce Reme from the Property. Regardless of whether or not Mortgagee, in person or by agent, takes actual possession of the Land and Improvements, unless Mortgagee agrees in writing to the contrary, Mortgagee is not and shall not be deemed to be:
 - (a) a "mortgagee in possession" for any purpose; or
- (b) responsible for performing any of the obligations of the lessor under any lease; or
- (c) responsible for any waste committed by lessees or any other parties, any dangerous or defective condition of the Property, or any negligence in the management, upkeep, repair or control of the Property; or
- (d) liable in any manner for the Property or the use, occupancy, enjoyment or operation of all or any part of it.
- 2.5 <u>Leasing.</u> Mortgagor shall not accept any deposit or prepayment of Rents for any rental period exceeding on (1) month without Mortgagee's prior written cor sent. Mortgagor shall not lease the Property or any part of it except strictly in accordance with this Mortgage.

III. Grant of Security Interest.

3.1 <u>Security Agreement.</u> The parties intend for this Mortgage to create a lien on the Property, and a security assignment of the Rents, all in favor of Mortgagee. The parties acknowledge that some of the Property, including, without limitation, all of Mortgagor's interest in and to the Loan funds, whether disbursed or not, any of Mortgagor's own funds now or later to be held on deposit with Mortgagee and any other bank accounts of Mortgagor, and some or all of the Rents which may be determined under applicable law to be personal property or fixtures. To the extent that any portion of the Property or Rents may be or are determined to be personal property, Mortgagor as debtor hereby grants Mortgagee as secured party a security interest in all

such Property and Rents, to secure payment and performance of the Secured Obligations. This Mortgage constitutes a security agreement under the Illinois Uniform Commercial Code, covering all such Property and Rents.

3.2 <u>Financing Statements.</u> Mortgagor shall execute one or more financing statements and such other documents as Mortgagee may from time to time require to perfect or continue the perfection of Mortgagee's security interest in the Property of Rents, any personal property, whether now in existence or hereafter acquired which is located on, at, or about the Property and any royalties, issues, profits, revenue, income, accounts proceeds, and other benefits of the Property, whether now due, past due, or to become due. As provided in Section 5.9, Mortgagor shall pay all see and costs the Mortgagee may incur in filing such documents in public offices and in obtaining such record searches as Mortgagee may reasonably require. In case Mortgagor fails to execute any financing statements or other documents for the perfection or continuation of any security interest, Mortgagor hereby appoints Mortgagee as its true and lawful attorney-in-fact to execute any such documents on its behalf. If any financing statement or other document is filed in the records normally pertaining to personal property, that filing shall never be construed as in any way derogating from or impairing Mortgage or the rights or obligations of the parties under it.

IV. Fixture Filing.

This Mortgage constitutes a financing statement filed as a fixture filing under Sections 9-313 and 9-402 of the Illinois Uniform Commercial Code, as amended or renotified from time to time, covering any Property which now is or later may become fixtures attached to the Land or Improvements.

V. Rights and Duties of the Parties

- 5.1 <u>Representations and Warranties.</u> Mortgagor represents and warrants that, except as previously disclosed to Mortgagee in a writing making reference to this section:
- (a) Mortgagor lawfully possesses and holds fee simple title to all of the Land and Improvements, unless Mortgagor's present interest in the Land is described in Exhibit A as a leasehold interest, in which case Mortgager lawfully possesses and holds a leasehold interest in the Land as stated in Exhibit A;
- (b) Mortgagor has or will have good title to all Property other than the Land and Improvements;
- (c) Mortgagor has the full and unlimited power, right and authority to encumber the Property and assign the Rents;
 - (d) this Mortgage creates a first and prior lien on the Property;

- (e) the Property includes all property and rights which may be reasonably necessary or desirable to promote the present and any reasonable future beneficial use and enjoyment of the Land and Improvements;
- (f) Mortgagor owns any Property which is personal property free and clear of any security agreements, reservations of title or conditional sales contracts, and there is no financing statement affecting such personal property on file in any public office; and
- (g) Mortgagor's place of business, or its chief executive office if it has more than one place of business, is located at the address specified below.

5.2 Taxes, Assessments, and Deposits.

- (a) Mortgagor shall pay prior to delinquency all taxes, levies, charges and assessments, including assessments on appurtenant water stock, imposed by any public or quasi-public authority or utility company which are (or if not paid, may become) a lien on all or part of the Property or any interest in it, or which may cause any decrease in the value of the Property or any part or it (all herein generally called "Taxes"), whether or not assessed against Mortgagor, and Mortgagor shall furnish to Mortgagee receipts therefor on or before the date the same are due; and shall discharge any claim or here relating to taxes upon the Property, other than matters expressly permitted by the terms of the Loan. Agreement. If any such taxes, levies, charges or assessments become delinquent, Mortgagee may require Mortgagor to present evidence that they have been paid in full, on ten (10) days' written notice by Mortgagee to Mortgagor.
- (b) In order to assure the payment of Γω es and insurance policy premiums ("Premiums") when due:
- Mortgagor shall, if required by Mortgagee, deposit into an escrow account established with Mortgagee on the fist business day of each month, an amount equal to one-twelfth (1/12) of the Taxes and premiums thereof to become due with respect to the Property between one and thirteen months after the date of such deposit; provided that in the case of the first such deposit, Mortgagor shall deposit in addition an amount which, when added to the aggregate amount of monthly deposits to be made hereunder with respect to Taxes and Premiums to become due within thirteen months after such first deposit, will provide a sufficient fund to pay such Taxes and premiums, one month prior to the date when they are due. The amounts of such deposits (herein generally called "Tax and Insurance Deposits") shall be based upon Mortgagee's estimate of the amount of Taxes and Premiums. Mortgagor shall promptly upon the demand of Mortgagee make additional Tax and Premiums. Deposits as Mortgagee may from time to time require due to (i) failure of Mortgagee to require, or failure of Mortgagor to make, Tax and Insurance Deposits in previous months, (ii) underestimation of the amounts of Taxes and /or Premiums, due dates and amounts of Taxes and/or Premiums, or (iii) application of the Tax and Insurance Deposits pursuant to paragraph 5.2 (iii) hereof. Additionally, upon the execution hereof, Mortgagor shall deposit with Mortgagor, as a Tax and Insurance Deposit, the

amount of all Taxes and Premiums to become due and payable prior to the first monthly Tax and Insurance Deposit or within on month thereafter.

- (ii) Mortgagee will, out of the Tax and Insurance Deposits, upon the presentation to Mortgagee by Mortgagor of the bills therefor, pay the Taxes and Premiums or will, upon the presentation of receipted bills therefor, reimburse Mortgagor for such payments made by Mortgagor. If the total Tax and Insurance Deposits on hand shall not be sufficient to pay all of the Taxes and Premiums when the same shall become due, then Mortgagor shall pay to mortgagee on demand the amount necessary to make up the deficiency;
- (iii) Upon a Default under this Mortgage, Mortgagee may, at its option, apply any Tax and Insurance Deposits on hand to the Secured Obligations, in such order and manner as Mortgagee may elect. When the Secured Obligations have been fully paid, any remaining Tax and insurance Deposits shall be paid to Mortgagor. All Tax and Insurance Deposits are hereby pledged as additional security for the Secured Obligations, and shall be paid to Mortgagor. All Tax and Insurance Deposits are hereby pledged as additional security for the Secured Obligations, and shall be held by Mortgagee irrevocable to be applied for the purposes for which made as herein provided, and shall not be subject to the direction or control of Mortgagor;
- (iv) Notwithstanding anything herein contained to the contrary, Mortgagee shall not be liable for any failure to pply the Tax and Insurance Deposits unless Mortgagor, while no Default exists hereunder, shall have (i) requested Mortgagee in writing to make application of such deposits to the payment of the Taxes or Premiums and (ii) presented Mortgagee with bills for such Taxes or Premiums; and
- (v) The provisions of this Mortgage are for the benefit of Mortgagor and Mortgagee alone. No provision of this Mortgage shall be construed as creating in any other party any rights in and to the Tax and Insurance Deposits or any rights to have the Tax and Insurance Deposits applied to payment of Taxes and Premiums. Mortgagee shall have no obligation or duty to any third party to collect Tax and Insurance Deposits
- 5.3 <u>Performance of Secured Obligations</u>. Mortgagor shall promptly pay and perform each Secured Obligation in accordance with its terms.
- 5.4 <u>Liens, Charges and Encumbrances</u>. Mortgagor shall immediately discharge any lien on the Property which Mortgagee has not consented to in writing. Mortgagor shall pay when due each obligation secured by or reducible to a lien, charge or encumbrance which now does or later may encumber or appear to encumber all or part of the Property or any interest in it, whether the lien, charge or encumbrance is or would be senior or subordinate to this Mortgage. This Section 5.4 is subject to any right granted to Mortgagor in the Loan Agreement to contest in good faith claims and liens for labor done and materials and services furnished in connection with construction of the Improvements.

5.5 Damages and Insurance and Condemnation Proceeds

- (a) Mortgagor hereby absolutely and irrevocably assigns to Mortgagee, and authorizes the payor to pay to Mortgagee, the following claims, causes of action, awards, payments and rights to payment:
 - (i) all awards of damages and all other compensation payable directly or indirectly because of a condemnation, proposes condemnation or taking for public or private use which affects all or part of the Property or any interest in it; and
 - (ii) all other rewards, claims and causes of action, arising out of any warranty affecting all or any part of the Property, or for damage or injury to or decrease in value of all or part of the Property or any interest in it; and
 - (in) all proceeds of any insurance policies payable because of loss sustained to all or part of the Property; and
 - (iv) all interest which may accrue on any of the foregoing.
 - (b) Mortgagor shall immediately notify Mortgagee in writing if:
 - (i) any damage occurs or any injury or loss is sustained in the amount of \$15,000 or more to all or part of the Property, or any action or proceeding relating to any such damage, injury or loss is commence; or
 - (ii) Any offer is made, or any action or proceeding is commenced, which relates to any actual or proposed condemnation of taking of all or part of the Property.
- (c) If mortgagee chooses to do so, it may in its own name appear in or prosecute any action or proceeding to enforce any cause of action based on warranty, or for damage, injury or loss to all or part of the Property, and it may make any compromise or settlement of the action or proceeding. Mortgagee, if it so chooses, may participate in any action or proceeding relating to condemnation or taking of all or part of the Property, and may join Mortgagor in adjusting any loss covered by insurance.
- (d) All proceeds of these assigned claims, other property and rights which Mortgagor may receive or be entitled to shall be paid to Mortgagee. In each instance, Mortgagee shall apply those proceeds first toward reimbursement of all of Mortgagee's cost and expenses of recovering the proceeds, first toward reimbursement of all of Mortgagee's costs and expenses of recovering the proceeds, including attorneys' fees. If, in any instance, each and all of the following conditions are satisfied in Mortgagee's reasonable judgment, Mortgagee shall permit Mortgagor to use the balance of the proceeds ("Net Claims Proceeds") to pay costs of repairing

or reconstructing the Property in the manner described below:

- (i) The plans and specifications, cost breakdown, construction contract, construction schedule, contractor and payment and performance bond for the work of repair or reconstruction must all be acceptable to Mortgagee.
- (ii) Mortgagee must receive evidence satisfactory to it that after repair or reconstruction, the Property would be at least as valuable as it was immediately before the damage or condemnation occurred.
- determination to pay for the total cost of repair or reconstruction, including all associated development costs and interest projected to be payable on the Secured Obligations until the repair or reconstruction is complete; or Mortgagor must provide its own funds in an amount equal to the difference between the Net Claims Proceeds and a reasonable estimate, made by Mortgagor and found acceptable by Mortgagee, of the total cost of repair or reconstruction.
- (iv) Mortgagee must receive evidence satisfactory to it that all leases which it may find acceptable will continue after the repair or reconstruction is complete.
 - (v) No Event of Default shall have occurred and be continuing.

If Mortgagee finds that the conditions are met, Mortgagee shall hold the Net Claims Proceeds and any funds which Mortgagor is required to provide in a non-interest-bearing account and shall disburse them to Mortgagor to pay costs of repair or reconstruction upon presentation of evidence reasonably satisfactory to Mortgagee that repair or reconstruction is as been completed satisfactorily and lien-free. However, if Mortgagee finds that one or more of the conditions are not satisfied, it may apply the Net Claims Proceeds to pay or prepay (without premium) some or all of the Secured Obligations in such order and proportions as it in its sole discretion may choose.

5.6 <u>Maintenance and Preservation of Property.</u>

- (a) Mortgagor shall insure the Property against such perils and hazards, and in such amounts and with such limits, as Mortgagee may from time to time require, and keep the Property in good condition and repair.
- (b) Mortgagor shall not remove or demolish the Property or any part of it, or alter, restore or add to the Property, or initiate or allow any change in any zoning or other land use classification which affects the Property or any part of it, except as permitted or required by the Loan Agreement or with Mortgagee's express prior written consent in each instance.

- (c) If all or part of the Property becomes damaged or destroyed, Mortgagor shall promptly and completely repair and/or restore the Property in a good and workmanlike manner in accordance with sound building practices, regardless of whether or not Mortgagee agrees to disburse insurance proceeds or other sums to pay costs of the work of repair or reconstruction under Section 5.5.
- which would violate: (i) any applicable law or order of any governmental authority, whether now existing or later to be enacted and whether foreseen or unforeseen; or (ii) any public or private covenant, condition, restriction or equitable servitude affecting the Property. Mortgagor shall not bring or keep any article on the Property or cause or allow any condition to exist on it, if that could invalidate a would be prohibited by any insurance coverage required to be maintained by Mortgagor on the Property or any part of it under the Loan Agreement.
- (e) Mortgagor shall not commit or allow waste of the Property, including those acts or omissions characterized under the Loan Agreement as waste which arises out of Hazardous Substances.
- (f) Mortgagor shall perform all other acts which from the character or use of the Property may be reasonably necessary to maintain and preserve its value.
- 5.7 <u>Releases, Extensions, Modifications and Additional Security</u>. From time to time, Mortgagee may perform any of the following acts without incurring any liability or giving notice to any person:
 - (i) release any person liable for rayment of any Secured Obligation;
