MEMORANDUM OF LEASE

This is a Memorandum CHICAGO TITLE AND TRUST COMPANY, as Trustee under Trust Agreement date: May 3, 1968 and known as Trust No. 52076 (hereinafter called "Landlord") and PANERA, LLC, a Delaware limited liability company (hereinafter called "Tenant"), upon the following terms:

Date of Lease: TUNE 17,2005

Description of Premises: See Exhibit A attached hereto.

Date of Commencement: The Commer coment Date shall be the earlier to occur of the following: (i) the day on which Tenant opens for business to the public in the Premises, or (ii) one hundred twenty (120) days after the Premises Delivery Date.

Term: Ten (10) Years expiring on the last day of the tenth (10th) Lease Year.

Renewal Options: Three (3) options of five (5) years each

Exclusive Use: So long as Tenant has not ceased to use the Fremises for a period in excess of one hundred eighty (180) consecutive days for any reason other than alterations, casualty, condemnation, force majeure or other reason beyond Tenant's reasonable control, Tenant shall have the exclusive right within the Center to sell bagels, freshly baked bread, and sandwiches. Notwithstanding the foregoing, Landlord and Tenant acknowledge and agree that Landlord shall be permitted to allow a restaurant use within the Center so long as (i) such use is not located within the building within which the Premises is located, and (ii) such restaurant use does not derive more than ten percent (10%) of its gross sales, in the aggregate, from the sale of bagels, freshly baked bread and sandwiches; provided, however, for the purposes of the foregoing, the sale of pizza, wraps, gyros, hamburgers, hot dogs, burritos, tacos, hot beef, sausage, meatballs, chicken sandwiches in which the chicken is grilled over an open flame and fish sandwiches shall not be considered "sandwiches" or "freshly baked bread".

The purpose of this Memorandum of Lease is to give record notice of the Lease and of the rights created thereby, all of which are hereby confirmed. Any and all defined terms used herein shall have the same meaning as ascribed thereto in the Lease, unless
