The original contract amount was \$21,500.00.
- 3. Styles entered into the Contract as the agent of Owner, and Claimant performed the work with the knowledge and consent of Styles and Owner. Alternatively, Owner authorized Styles to enter into the Contract individually. Alternatively, Owner knowingly permitted Styles to enter into the Contract for the improvement of the Real Estate.
- 4. Claimant completed the work for which Claimant claims a lien on or about January 23, 2012.
- 5. As of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of \$11,500.00, which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate and against all ownership or leasehold interests in the Real Estate (including all land and improvements thereon) in the amount of \$11,500.00 plus interest.
