Alternatively, a separate contract was entered into by Northwest with Metropolitan Construction Services-Illinois, LLC ("Metropolitan") or others authorized or knowingly permitted by the Owner or the Owner's agent to serve as the General Contractor for the improvement of the Real Estate and, in return, Northwest entered into the Contract with the Claimant to assist Northwest in the performance of its work for Metropolitan to improve the Real Estate.
- 5. At the request of Northwest, the Claimant agreed to supply additional materials for the improvement of the Real Estate.
- 6. C'air ant substantially completed its supplying of materials under the Contract and in connection with the solditional materials Northwest requested on December 30, 2011.
- 7. As of the date hereof, there is due, unpaid, and owing to Claimant for the materials it supplied under the Contract, after allowing all credits, the principal sum of \$20,425.71 plus 2% monthly service charges thereon until paid. In addition, the amount due to the Claimant bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$20,425.71, plus 2% monthly service charges thereon, plus 10% statutory interest chereon, plus the attorneys' fees and costs that Claimant incurs and has incurred in prosecuting its claim.
