

This Second Amendment to Declaration of Condominion as a Result of Transfer of Limited Common Elements (the "Amendment") dated as of the 1st day of December, 2011.

WITNESSETH:

WHEREAS, on July 1, 2003, Smithfield Properties XV, L.L.C., an Initial liability company, recorded a Declaration of Condominium Ownership for Kingsbury on the Park Condominium in the Office of the Recorder of Deeds of Cook County, Illinois as Document 0318227049 (as amended from time to time, the "Declaration") with respect to the Property described therein, creating Kingsbury on the Park Condominium (the "Condominium"); and

WHEREAS, Unit Owners may transfer Limited Common Elements appurtenant to their 'Un'ts as provided in the Declaration and the Illinois Condominium Property Act (the "Act"), upon recordation of an amendment to the Declaration in accordance with the terms of the Act and the Declaration; and

WHEREAS, Craig J. DellaValle ("Craig") owns fee simple title to Unit 1405 in the Condominium and limited common element parking space 34; and

WHEREAS, Shari M. Friedman ("Shari") owns fee simple title to Unit 1605 in the Condominium and limited common element parking space 81; and

WHEREAS, Craig, as the Unit Owner of Unit 1405, now desires to transfer all of his right, title and interest in Limited Common Element Parking Spaces 100, 131, 139, and 146, limited common elements appurtenant to Unit 1405, to Shari, as the Unit Owner of Unit 1605, on behalf of and as nominee for the Kingsbury on the Park Condominium Association ("Association"), in accordance with the Declaration and the Act.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Craig and the Association hereby amend the Declaration as follows:

- 1. The preambles set forth above are incorporated into this Amendment and shall be deemed to be terms and provisions hereof, the same as if fully set forth in this Section 1.
- 2. All capitalized terms used herein and defined in the Declaration shall have the meanings ascribed to such terms in the Declaration.
- 3. Craig hereby transfers Limited Common Element Parking Spaces 100, 131, 139, and 146 to Shari, on behalf of and as nominee for the Association, and Shari hereby accepts such transfer on behalf of and as nominee for the Association, making Limited Common Element Parking Spaces 150, 131, 139, and 146 appurtenant to Unit 1605.
- 4. Notwithstarding anything herein to the contrary, Craig is not transferring Limited Common Element Parking Space 34, which shall remain owned by Craig as appurtenant to Unit 1405.
- 5. No changes are being made to any Unit Owner's proportionate ownership interest in the Common Elements by reason of tris transfer.
- 6. The legal description of Unit 1605, including Limited Common Element Parking Spaces 100, 131, 139, and 146 appurtenant to Unit 1605 being transferred hereunder, as affected by the recording of this Amendment in the office of the Recorder of Deeds of Cook County, Illinois, is set forth on Exhibit A hereto.
- 7. The legal description of Unit 1405 after the recording of this Amendment in the office of the Recorder of Deeds of Cook County, Illinois is set forth on **Exhibit B** hereto.
 - 8. This Amendment shall be effective upon its recording.
- 9. Shari acknowledges that a copy of this Amendment has been delivered to the Board of Managers of the Condominium.
