AN ORDINANCE APPROVING A PLAT OF DEDICATION FOR THE ALLEY LOCATED SOUTH OF DEMPSTER STREET BETWEEN NILES CENTER ROAD AND SKOKIE BOULEVARD, SKOKIE, ILLINOIS IN A B3 BUSINESS DISTRICT

WHEREAS, a residential apartment building to the south and a proposed commercial development to be located at 4811 Dempster Street will utilize the alley for access; and

WHEREAS, the Community Development Director reviewed the Plat of Dedication and determined that the dedication meets all Village requirements and has recommended its acceptance as indicated in his memorandum dated January 30, 2012; and




