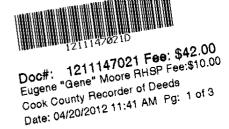

EXHIBIT "A"

PERMITTED EXCEPTIONS TO TITLE

- 1. GENERAL REAL ESTATE TAXES FOR 2011 AND SUBSEQUENT YEARS, NOT YET DUE AND PAYABLE.
- 2. (A) RIGHTS OF THE MUNICIPALITY, STATE OF ILLINOIS, THE PUBLIC AND ADJOINING OWNERS IN AND TO VACATED ALLEY.
 - (B) RIGHTS OF THE PUBLIC OR QUASI-PUBLIC UTILITIES, IF ANY, IN SAID VACATED ALLEY FOR MAINTENANCE THEREIN OF POLES, CONDUITS, SEWERS, ETC.
- 3. RIGHTS OF THE CITY OF CHICAGO TO THE WATER TUNNEL DIAGONALLY CROSSING THE LAND FROM THE NORTHEAST CORNER IN A SOUTHWESTERLY DIRECTION AT APPROXIMATELY 86 TO 100 FEET BELOW GRADE, AS SHOWN ON SHEET A0.1 OF THE PLANS AND SPECIFICATIONS PREPARED BY HARTSHORNE PLUNKARD ARCHITECTURE DATED JANUARY 15, 2007, ENTITLED "SUPERIOR 110".

ACCORDING TO SAID PLANS, THE TUNNEL LIES SOUTH OF A LINE DRAWN FROM A POINT IN THE NORTH LINE OF THE LAND, 2 FEET, 11-5/8 INCHES WEST OF THE NORTHEAST CORNER THEREOF TO A POINT IN THE WEST LINE, 48 FEET 10 INCHES SOUTH OF THE NORTHWEST CORNER, AND NORTH OF A LINE FROM A POINT IN THE EAST LINE, 16 FEET, 10-3/16 INCHES SOUTH OF THE NORTHWEST CORNER TO A POINT ON THE WEST LINE, 67 FEET, 6-11/16 INCHES SOUTH OF THE NORTHWEST CORNER.

- 4. GRANTOR ALSO HEREBY GRANTS TO THE GRANTEE, THEIR SUCCESSORS AND ASSIGNS, AS RIGHTS AND EASEMENTS APPURTENANT TO THE SUBJECT UNIT DESCRIBED HEREIN, THE RIGHTS AND EASEMENTS FOR THE INFLICT OF SAID UNIT SET FORTH IN THE DECLARATION OF CONDOMINIUM, AND GRANTOK RESERVES TO ITSELF, ITS SUCCESSORS AND ASSIGNS, THE RIGHTS AND EASEMENTS SET FORTH IN SAID DECLARATION FOR THE BENEFIT OF THE REMAINING LAND DESCRIBED THERFIN. THIS DEED IS SUBJECT TO ALL RIGHTS, EASEMENTS, COVENANTS, RESTRICTIONS, AND RESERVATIONS CONTAINED IN SAID DECLARATION THE SAME AS THOUGH THE PROVISIONS OF SAID DECLARATION WERE RECITED AND STIPULATED AT LENGTH HEREIN.
