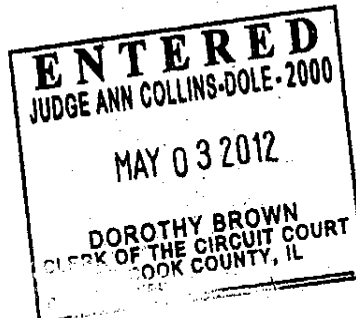
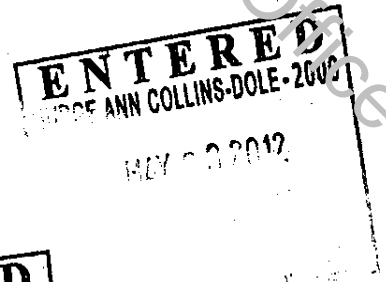
On May 3 2012, judgment was entered in this court in favor of the plaintiff,
