NOW THEREFORE, THE DECLARATION AND BY-LAWS
AND THE AMENDMENT THERETO DESCRIBED
HEREINABOVE ARE AMENDED AS FOLLOWS:

- 1. Article VI, Section 7.14, LEASING is deleted in its entirety
- 2. In lieu thereof, Article VII, Section 7.14, LEASING shall be as follows:

Leasing of a Unit is permitted under the following conditions:

1. No more than five (5) units may be leased at any given time.

- 2. A Unit Owner desiring to lease must have been a resident owner for at least two (2) years.
- 3. Leases of a unit to a parent, grandparent, child or grandchild are not subject to the restrictions set forth herein.
- 4. Hardship cases may be permitted at the sole discretion of the Board.
- 5. The Board shall promulgate reasonable rules to give effect to the foregoing Amendment.

Except to the extent expressly set forth hereinabove, the provisions of the Declaration as previously Amended shall continue in full force and effect.
