WHEREAS, pursuant to <u>Section 3.5(b)</u> of the Original Declaration, Declarant has the authority, without obtaining the consent of any other party, to make any amendment to the Declaration necessary to reallocate and reassign the Parking Spaces theretofore assigned to such Units and, if necessary, to change the percentage of ownership interest in the Common Elements attributable to such Units.

WHEREAS, Declarant desires to reassign certain of the Parking Spaces assigned to certain of the Units, subject to the terms and conditions of this Third Amendment.

- NOW, CHEREFORE, for and in consideration of the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Declarant hereby agrees as follows:
- Section 1: Definitions. All terms used but not defined in this Third Amendment shall have the meanings ascribed to such terms in the Original Declaration.
- Section 2: Exhibit C. Ex'nbit C to the Original Declaration is hereby deleted in its entirety and is replaced with Exhibit C to this Third Amendment.
- Section 3: Full Force and Effect; Inconsistencies. The Original Declaration (as modified by this Third Amendment) and the recitals and exhibits to this Third Amendment are hereby incorporated into this Third Amendment by this reference. Except as set forth in this Third Amendment, the terms, covenants, conditions and agreements of the Original Declaration shall remain unmodified and otherwise in full force and effect. In the event of any inconsistency between the terms of the Original Declaration and the terms of this Third Amendment, the terms of this Third Amendment shall control.
- Section 4: Recordation. This Third Amendment shall be recorded with the Recorder of Deeds for Cook County, Illinois.
- Section 5: Counterparts. This Third Amendment may be executed in any number of counterparts, each of which shall be deemed to constitute an original hereof. True signature of any party to any counterpart shall be deemed a signature to, and may be appended to any other counterpart.
