AGREED ORDER

The parties, pursuant to 725 ILCS 150/11 having agreed by and between themselves to a settlement of these proceedings. The Court hereby finds that:

- 1. The only Claimant in this matter is Darlene Parisi.
- 2. There is no appearance and/or answer to the Complaint filed herein by James Parisi, who was properly notified and is now found to be in default.
 - 3. The Court has jurisdiction over the subject matter of this proceeding.
- 4. That the People of the State of Illinois, would meet its burden of proof on the Complaint for forfeiture filed herein.
 - 5. That the above described real property is hereby forfeited to the People of the State of Illinois

and the Director of the Illinois State Police shall take immediate possession of the real property and is ordered to sell the above described real property pursuant to statute.

- 6. That after the sale of the above described real property, the Director of the Illinois State Police is ordered to deduct the cost of the sale of said property from gross proceeds.
- 7. The parties have agreed that the proceeds of the sale of the real property shall be distributed as follows:

50% of the net proceeds paid to Darlene Parisi(after all cost have been paid)

50% of the net proceeds to be forfeited to the directors of the state police to be distributed pursuant to the Illinois Drug Asset Forfeiture Act and 720 ILCS 570/505.

NOW THEFATORE IT IS ORDERED:

- A. That any right, title, and/or interest of James Parisi in the defendant property is hereby terminated.
- B. The property described in the Complaint for Forfeiture filed in this proceeding is forfeited to the Director of the Illinois State Police.
- C. The Director of the Illinois State Fonce, is directed to sell the property in accordance with the Illinois Drug Asset Forfeiture Act as set forth in paragraph C. of this Order.
 - D. The net proceeds of the sale shall be distributed as follows:

50% shall be distributed to Darlene Parisi
50% shall be forfeited to the directors of the state police to be distributed pursuant to the Illinois Drug Asset Forfeiture Act and 720 ILCS 570/505

E. That the cost of publication herein \$371.07 shall be paid to the Stre's Attorney of Cook County, Illinois from the State's projects.
