MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated May 8, 2012, is made and executed between Timothy F. Dwyer and Laura Verkest Dwyer, husband and wife, as tenants by the entirety, whose address is 1057 Linden Ave., Wilmette, IL 60091 (referred to below as "Grantor") and NORTH SHORE COMMUNITY BANK & TRUST COMPANY, whose address is 7800 Lincoln Avenue, Skokie, IL 60077 (referred to below as "Lender").

It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly





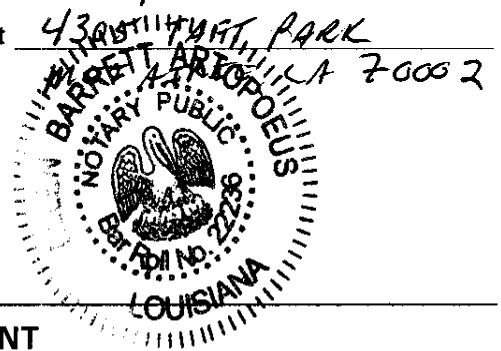
