MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated May 1, 2012, is made and executed between Jalaramdev Inc, a Corporation (referred to below as "Grantor") and Heritage Bank of Schaumburg, whose address is 1535 W. Schaumburg Road, Schaumburg, IL 60194 (referred to below as "Lender").

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

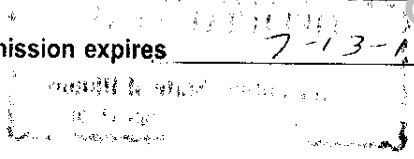

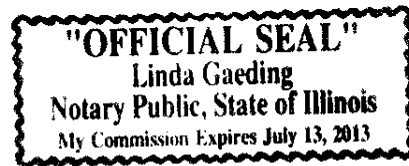
