**MAXIMUM LIEN.** At no time shall the principal amount of indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$3,000,000.00.

**THIS MORTGAGE** dated April 1, 2012, is made and executed between **GREAT LAKES TRUST COMPANY AS SUCCESSOR TRUSTEE OF THE FIRST NATIONAL BANK OF BLUE ISLAND**, UNDER TRUST AGREEMENT DATED JULY 10, 1992 AND KNOWN AS TRUST NUMBER 92057 (referred to below as "Grantor") and **FIRST NATIONAL BANK OF ILLINOIS**, whose address is 19860 LA GRANGE RD., MOKENA, IL 60448 (referred to below as "Lender").

**GRANT OF MORTGAGE.** For valuable consideration, Grantor not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to Grantor pursuant to a Trust Agreement dated July 10, 1992 and known as GREAT LAKES TRUST COMPANY AS SUCCESSOR TRUSTEE OF THE FIRST NATIONAL BANK OF BLUE ISLAND TRUST NUMBER 92057, mortgages and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, (the "Real Property") located in Cook County, State of Illinois:

For such purposes, Grantor hereby irrevocably appoints Lender as Grantor's attorney-in-fact for the purpose of making, executing, delivering, filing, recording, and doing all other things as may be necessary or desirable, in Lender's sole opinion, to accomplish the matters referred to in the preceding paragraph.

**Adverse Change.** A material adverse change occurs in Grantor's financial condition, or Lender believes the prospect of payment or performance of the Indebtedness is impaired.

**Insecurity.** Lender in good faith believes itself insecure.

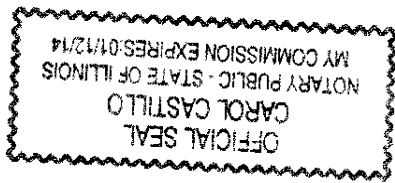
