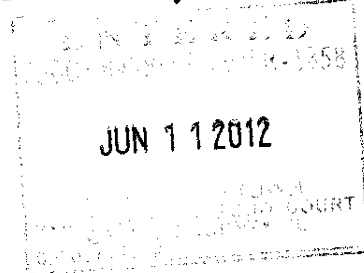

### ORDER

This Court orders:

- The Court shall allow a Uniform Order for Support to be entered for the Current Support of \$1,500.00 a month and \$400.00 a month until the total amount of \$5,200.00 is paid pursuant to the November 14, 2011 court order.
- Gene Radwanski is held in default for his failure to appear today.
- Gene Radwanski shall pay the sum of \$8,147.50 for Sheila's attorney fees pursuant to 508(c) & 508(b). Judgment is entered in favor of Sheila Walsh + against Gene Radwanski in the amount of \$8,147.50. (and Gene Radwanski insurance agency)
