**AMENDMENT TO MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF
LEASES AND RENTS AND FIXTURE FILING AND
ASSIGNMENT OF RENTS AND LEASES AND PARTIAL RELEASE**

**THIS AMENDMENT TO MORTGAGE, SECURITY AGREEMENT,
ASSIGNMENT OF LEASES AND RENTS AND FIXTURE FILING AND OTHER LOAN
DOCUMENTS AND PARTIAL RELEASE** (this "Amendment"), dated as of June 12, 2012
(the "Effective Date"), is entered into by and among 318 SOUTH MICHIGAN AVENUE,
L.L.C., an Illinois limited liability company ("Mortgagor" or "Assignor", as the case may be),
318 RETAIL, L.L.C., an Illinois limited liability company ("Retail Mortgagor"; together with
Mortgagor, the "Original Mortgagors"), and BIXBY BRIDGE FUND I, LLC, an Illinois
limited liability company (together with its successors and assigns "Mortgagee" or "Assignee",
as the case may be), with respect to the following Recitals:

RECITALS

A. Mortgagee made a loan to Original Mortgagors (the "Original Loan") in the original principal amount of \$2,900,000.00 pursuant to that certain Loan Agreement dated as of May 27, 2011, between Original Mortgagors and Mortgagee (as amended, the "Loan Agreement"). The Original Loan is evidenced by that certain Promissory Note dated as of May 27, 2011, in the original principal amount of the Original Loan, executed by Original Mortgagors, as makers, in favor of Mortgagee, as holder (the "Original Note"). All initially-capitalized terms not otherwise defined herein shall have the meanings given such terms in the Loan Agreement.

B. The repayment of the Original Note and the performance of Original Mortgagors' obligations under the Original Note and other Loan Documents are secured, inter alia, by that certain Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing dated as of May 27, 2011, executed by Original Mortgagors to and for the benefit of Mortgagee,

recorded on June 7, 2011 as Document No. 1115804175 with the Recorder of Deeds Cook County, Illinois (the "**Original Mortgage**", and as amended the "**Mortgage**"), and that certain Assignment of Rents and Leases dated as of May 27, 2011, executed by Original Mortgagors to and for the benefit of Assignee, recorded on June 7, 2011 as Document No. 1115804176 with the Recorder of Deeds Cook County, Illinois (the "**Original ARL**", and as amended, the "**ARL**").

C. Original Mortgagors have requested that Mortgagee divide the Original Loan into two (2) loans, one to Retail Mortgagor in the amount of \$1,350,000.00 (the "**Retail Loan**") and the other to Mortgagor in the amount of \$1,550,000.00 (as increased as provided below, the "**Residential Loan**")

D. In conjunction with dividing the Original Loan into two (2) loans, Mortgagor has requested and Mortgagee has agreed to release the Retail Real Estate (as defined in the Original Mortgage) from the Mortgage and ARL, and only the Residential Real Estate (as defined in the Original Mortgage), and legally described on Exhibit A attached hereto, will continue to be encumbered by the Mortgage and ARL.

E. Mortgagor has also requested that Mortgagee make available and advance an additional \$500,000.00 as an increase to the Residential Loan so that the Residential Loan is in the principal amount of \$2,050,000.00. Mortgagee has agreed to this request on the terms and conditions set forth in the Loan Agreement.

F. Original Mortgagors and Mortgagee desire to amend the Mortgage and ARL on the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the foregoing Recitals, the mutual covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Recitals. The foregoing recitals are hereby incorporated by this reference into this Amendment.
2. Amendments to Mortgage. The Mortgage is hereby amended as follows:
 - a) Any references to the Mortgagors (as defined in the Original Mortgage) shall now reference the Mortgagor, and any references to the Retail Mortgagor are hereby deleted.
 - b) Any references in the Mortgage to the "**Note**" shall refer to the Amended and Restated Promissory Note by Mortgagor in favor of Mortgagee, dated as of even date herewith, in the original principal amount of \$2,050,000.00.
 - c) Any references in the Mortgage to the amount of the Loan shall refer to \$2,050,000.00, and all references to "\$2,900,000" are hereby changed to "\$2,050,000."
 - d) Section 35(j) of the Mortgage is amended to reflect that the maximum Indebtedness secured by the Mortgage shall not exceed \$4,100,000.00.

e) The Retail Real Estate (as defined in the Original Mortgage and legally described in Exhibit B attached hereto) is hereby released, and Exhibit A-2 is hereby deleted from the Mortgage.

f) The definition of "**Real Estate**" is hereby amended to only include the Residential Real Estate (as defined in the Original Mortgage).

g) Exhibit A-1 shall now be considered Exhibit A, and all references to Exhibit A-1 are hereby changed to Exhibit A.

h) The Maturity Date of the Mortgage and Amended and Restated Promissory Note have been extended to May 31, 2013.

i) Interest under the Note shall accrue on the outstanding principal balance of the Note at an annual rate equal to thirteen and one-half percent (13.5%), computed and compounded monthly (the "**Loan Rate**"). From and after the Maturity Date or upon the occurrence of an Event of Default, interest shall accrue on the balance of the principal remaining unpaid during any such period at an annual rate equal to five percent (5%) plus the Loan Rate.

j) Any references in the Mortgage to the Prepayment Premium (as defined in the Mortgage) shall be deleted, and such references shall be replaced with references to the \$55,000 Exit Fee.

3. Amendments to ARL. The ARL is hereby amended as follows:

a) Any references in the ARL to the Assignors (as defined in the Original ARL) shall now reference the Assignor, and any references to the Retail Assignor are hereby deleted.

b) Any references in the ARL to the "**Note**" shall refer to the Amended and Restated Promissory Note by Assignor in favor of Assignee, dated as of even date herewith, in the original principal amount of \$2,050,000.00.

c) The Retail Premises (as defined in the ARL) is hereby released, and Exhibit A-2 is hereby deleted from the ARL.

d) The definition of "**Premises**" is hereby amended to only include the Residential Premises (as defined in the Original ARL).

e) Exhibit A-1 shall now be considered Exhibit A, and all references to Exhibit A-1 are hereby changed to Exhibit A.

4. References. All references in the Mortgage and ARL to the Loan Agreement or any of the other Loan Documents shall refer to the Loan Agreement or any of the other Loan Documents as amended by the Amendment to Loan Agreement and Other Loan Documents, as of even date herewith (as same may be further amended, restated, replaced, supplemented or otherwise modified from time to time).

5. No Defenses. Original Mortgagors hereby acknowledge that (i) as of the Effective Date it has no defense, offset or counterclaim with respect to the payment of any sum owed to Mortgagee, or with respect to any covenant in the Loan Documents; (ii) Mortgagee, on and as of the date hereof, has fully performed all obligations to Original Mortgagors which it may have had or has on and as of the date hereof; and (iii) by entering into this Amendment, Mortgagee does not waive any condition or obligation in the Loan Documents.

6. No Impairment. Nothing herein contained shall impair the Loan Agreement, Amended and Restated Promissory Note or other Loan Documents in any way, nor alter, waive, annul, vary nor affect any provision, condition or covenant therein contained except as expressly herein provided nor affect or impair any right, power or remedy of Mortgagee, it being the intention of the parties hereto that the terms and provisions of the Loan Agreement, Amended and Restated Promissory Note and other Loan Documents shall continue in full force and effect except as expressly modified in connection herewith.

7. Successors and Assigns. This Amendment shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto.

8. Reaffirmation. The Original Mortgagors hereby ratify and reaffirm the obligations, waivers, indemnities, representations, warranties and covenants made by the Original Mortgagors in the Mortgage and ARL, as amended hereby.

9. Continuing Effect. Except as expressly provided herein, all of the terms, provisions, debts, duties, obligations, liabilities, representations and warranties, rights, titles, security interests, liens, powers and privileges existing by virtue of the Mortgage and ARL, as amended or modified hereby, shall be and continue in full force and effect, and are hereby acknowledged by Original Mortgagors to be legal, valid, binding and enforceable in accordance with their terms.

10. Further Assurances. In addition to the documents, instruments and acts described in this Amendment which are to be executed, or delivered or taken pursuant to this Amendment, the Original Mortgagors agree to execute and deliver from time to time upon request by Mortgagee such other documents and instruments, and take such other action, as Mortgagee may request or require to more fully and completely evidence and carry out the transactions contemplated by this Amendment.

11. Counterparts. This Amendment may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which counterparts taken together shall constitute but one and the same instrument. Signature and acknowledgment pages may be detached from the counterparts and attached to a single copy of this Amendment to physically form one document.

12. No Novation. This Amendment will not constitute a novation or have the effect of discharging any liability or obligation evidenced by the Loan Documents.

13. No Amendment. No extension, change, modification or amendment of any kind or nature whatsoever, to or of this Amendment shall be made or claimed by the Original Mortgagors, and no notice of any extension, change, modification or amendment, made or

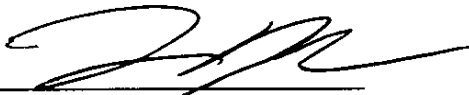

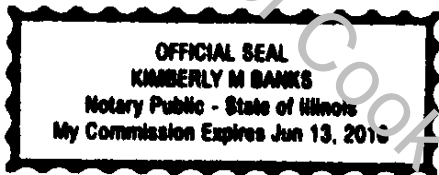
