Exhibit "A"

Legal description for the property on 3418 N. Knox Avenue, Chicago, IL is as follows:

Parcel 1:

Lots 1 and 2 in Block 3 and all of the vacated street lying between and adjoining Lot 24 in Block 2 and Lot 1 in Block 3 E.L. Smith's Addition to Irving Park, a subdivision in the North 1/2 of the East 40 acres of the West 1/2 of the Southwest 1/4 of Section 22, Township 40 North, Range 13, East of the Third Principal Meridian, except the Fast 5 acres thereof recorded July 12, 1871 and rerecorded June 3, 1872 in Cook County, Illinois (excepting therefrom the following described part of said Lot 2 in Blocks in E.L.
