This Third Amendment to Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Rand/Olive Office & Financial Center Condominium (the "Third Amendment") is an amendment to that certain Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Rand/Olive Office & Financial Center Condominium recorded in the office of the Recorder of Deeds of Cook County, Illinois, on September 21, 1982, as Document Number 26357751 (the "Declaration").

WITNESSETH:

WHEREAS, certain real property located in unincorporated portion of Cook County, Illinois, has been submitted to the provisions of the Illinois Condominium Property Act (the "Act") and the Declaration, such condominium being known as Rand/Olive Condominium, which real property is legally described in Exhibit "A" (incorporated herein and attached hereto); and

WHEREAS, Rand/Olive Condominium Association, Inc., an Illinois not-for-profit corporation (the "Association"), administers the property as set forth and described in the Declaration; and

WHEREAS, pursuant to Article XIX, Paragraph 6 of the Declaration, provisions in the Declaration may be amended, changed or modified by an instrument in writing setting forth such amendment, change or modification, signed and acknowledged by all of the members of the Association's Board of Managers (the "Board") and at least three-fourths (3/4) of the Unit Owners, approved by any mortgagees required under the provisions of the Condominium Instruments and containing an affidavit by an officer of the Board certifying that a copy of the amendment, change or modification has been mailed by certified mail to all mortgagees having bona fide liens of record against any Unit, not less than ten (10) days prior to the date of such affidavit; and

WHEREAS, this Third Amendment has been signed and acknowledged by all of the Board members and at least three-fourths (3/4) of the Unit Owners, as evidenced by the signatures incorporated herein and attached hereto; and

WHEREAS, attached hereto is an affidavit signed by the Secretary of the Association certifying that (a) this Third Amendment has been signed and acknowledged by all of the Board members and at least three-fourths (3/4) of the Unit Owners; and (b) a copy of this Third Amendment has been mailed by certified mail to all mortgagees having bona fide liens of record against any Unit, not less than ten (10) days prior to the date of the affidavit.

NOW, THEREFORE, the Association hereby declares that the Declaration be and hereby is amended as follows.

The Association hereby declares that the Declaration be and hereby is amended with regard to Article XIV, Paragraph (a), and said Article XIV, Paragraph (a) is deleted in its entirety and replaced with the following Paragraph 1.1:

1.1. Board of Managers - In General. The direction and administration of the Association shall be vested in the Board, which shall act as the Board of Managers of the Association as provided in the Act and this Declaration.

The Association hereby declares that the Declaration be and hereby is amended with regard to Article XIV, Paragraph (b), and said Article XIV, Paragraph (b) is deleted in its entirety and replaced with the following Paragraphs 1.2, 1.3, 1.4 and 1.5:

1.2. Board of Managers - Number, Tenure, Qualifications and Compensation.

(a) The terms of all existing members of the Board shall expire as of the date of the first annual meeting of the Unit Owners to be convened subsequent to the effective

date of this amended Article XIV, after which time there shall be three (3) members of the Board. Commencing with the date of the first annual meeting of the Unit Owners to be convened subsequent to the effective date of this amended Article XIV, the terms of members of the Board shall be staggered as follows: the three (3) candidates receiving the greatest number of votes shall be elected to the Board; the two (2) candidates receiving the greatest number of votes each shall be elected for a term of two (2) years and until his or her successor shall have been elected and qualified, and the one (1) candidate receiving the next highest number of votes shall be elected for a term of one (1) year and until his or her successor shall have been elected and qualified. Commencing at the second annual meeting of the Unit Owners to be convened subsequent to the effective date of this amended Article XIV, and during each year thereafter, each elected member of the Board shall serve for a term of two (2) years and until his or her successor shall have been elected and qualified. The terms of at least one-third (1/3) of the members of the Board shall expire annually. A member of the Board may succeed himself or herself in office.

(b) Members of the Board shall be elected solely by, from and among the Unit Owners. All members of the Board shall be elected at large. If there are multiple Owners of a single Unit, only one of the multiple Unit Owners shall be eligible to serve as a member of the Board at any one time. In the event that a Unit Owner is a corporation, partnership, trust or other legal entity other than a natural person or persons, then any director, officer or other designated agent of such corporation, partner or other designated agent of such partnership, beneficiary, individual trustee or other designated agent of such trust or manager or other designated agent of such other legal entity may be eligible to serve as a member of the Board. The Association, in the Board's sole discretion, shall have the right (but no affirmative obligation), to require that a member of or a candidate for the Board furnish documentation and/or other information adequately verifying that the Board member or candidate is eligible to serve on the Board. Such information may include, without limitation, true and correct copies of recorded deeds, corporate resolutions, partnership agreements, operating agreements, and/or trust agreements. For the purposes of this paragraph, decisions regarding whether such verification is adequate shall be made by the Association in the Board's sole discretion.

(c) Each member of the Board shall hold office without compensation, provided, however, that upon the presentation of receipts or other appropriate documentation, a Board member shall be reimbursed by the Association for reasonable out-of-pocket expenses incurred in the course of his or her performance of his or her duties as a Board member.

1.3. Board of Managers - Election Procedures.

(a) At each annual meeting of the Unit Owners, the Unit Owners shall be entitled to elect Board members, and the candidates receiving the highest number of votes with respect to the number of offices to be filled shall be deemed to be elected. The election as between candidates receiving the same number of votes shall be determined by lot. Cumulative voting shall not be permitted. A candidate for election to the Board or such

candidate's representative shall have the right to be present for the counting of the ballots at such election.

(b) Upon adoption of appropriate rules and regulations by the Board, the election may be conducted by secret ballots distributed by the Association, provided that the Board further adopts rules to verify the status of the Unit Owner issuing a proxy or casting a ballot.

1.4. Board of Managers - Quorum and Manner of Acting. A majority of the members of the Board shall constitute a quorum for the transaction of business at any meeting of the Board. The action of a majority of the members of the Board present at the meeting at which a quorum is present shall be the action of the Board, except when otherwise provided by law or in this Declaration.

1.5. Board of Managers - Vacancies and Resignations.

(a) Any vacancy occurring on the Board may be filled by the two-thirds (2/3) vote of the remaining members of the Board. A Unit Owner elected by the Board to fill a vacancy shall serve until the next annual meeting of the Unit Owners, provided that if a petition is filed with the Board signed by the Unit Owners holding twenty percent (20%) of the votes of the Association requesting a meeting of the Unit Owners to fill the vacancy for the balance of the unexpired term of office of his or her predecessor, the term of the member of the Board so elected by the Board shall terminate thirty (30) days after the filing of the petition, and a meeting of the Unit Owners for the purpose of filling such vacancy for such unexpired term shall be called no later than thirty (30) days following the filing of such petition.

(b) Members of the Board may resign at any time by written resignation delivered or mailed to any officer of the Association, which resignation shall be effective upon receipt.

Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms. The effective date of this Third Amendment shall be deemed to be the date of recording with the office of the Recorder of Deeds of Cook County, Illinois.
