As of the Effective Date hereof, the Mortgage and Assignment are hereby amended to evidence that the Note (i) is in the principal sum of \$735,906.49; (ii) the interest rate applicable to the Note has been changed to five percent (5%) per annum and payments are based on a 23 year amortization schedule; and (iii) the Maturity Date of the Note is March 15, 2014, unless extended. All other terms of the Mortgage and Assignment, as previously amended, shall remain the same.

4. Grantor acknowledges that there are no other understandings, agreements or representations, either oral or written, express or implied, that are not embodied in the Loan Documents and this Amendment.






