#### COLLATERAL

Debtor hereby grants to Secured Party a continuing security interest in, and assigns, hypothecates and transfers to Secured Party, the following property or types of property now owned by Debtor or hereafter created or acquired by Debtor, wherever located:

- (a) Accounts (including without limitation all rights to payment for services or the Inventory, as the same is hereinafter defined) however arising, and all rights to payment under leases of real property and the Economent (as the same is hereinafter defined), any other leases, chattel paper, contract rights, instruments, life insurance policies, and documents (the "Accounts");

- (g) All books and records, including without limitation customer lists, credit files, computer programs, printouts, and other materials and records, pertaining to any of the foregoing;
