#### MEMORANDUM OF ASSIGNMENT OF LEASE

This Mernorandum of Assignment of Lease is entered into as of July 2, 2012 between W. Sanford Kasten and Jennifer Kasten ("Assignor") and Dominick Mondi and Cynthia Mondi ("Assignee").

- 1. **Premises**. On July 2, 2012, for sufficient consideration received and pursuant to a certain Assignment and Acceptance of Lease, a copy of which is attached hereto as Exhibit A (the "Assignment"), Assignor assigned to Assignee all of its right, title and interest as lessee under that certain Indenture of Lease between Michigan Building Corporation ("Lessor") and Assignor, via mesne assignments (as amended, the "Proprietary Lease") for the premises commonly known as 229 E. - 3. **Incorporation; Conflicts**. All of the terms and conditions of the Proprietary Lease are incorporated herein by reference as though fully set forth helein. In the event of any conflict between the terms hereof and the terms of the Proprietary Lease, the Proprietary Lease shall prevail.


