Whether or not Borrover is residing in the Property. Borrower shall maintain the Property in order to prevent the Property from decriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that repair or restoration is not economically feasible. Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. 
