**MAXIMUM LIEN.** At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$40,800.00.

**THIS MORTGAGE** dated May 25, 2012, is made and executed between Mack Investments I, LLC, An Illinois Limited Liability Company, whose address is 16800 S. **Right to Contest.** Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized.
