JUDGMENT VESTING ABSOLUTE TITLE IN MORTGAGE

This matter has come before the Court on Intervening Plaintiff 1000 East Woodfield Loan Holdings, LLC's ("Mortgagee") Motion for Entry of Consent Judgment of Foreclosure (the "Motion") against 1000 East Woodfield Associates, LLC ("Mortgagor"). This Court having considered the Stipulation for Entry of Consent Judgment of Foreclosure between Mortgagee and Mortgagor and Mortgagee's Amended Verified Complaint for Consent Foreclosure (the "Complaint"), the Motion, and Mortgagor's Verified Answer (the "Answer"), and pursuant to

Section 15-1402 of the Illinois Mortgage Foreclosure Law (“IMFL”), 735 ILCS 5/15-1402, and the Court, being fully advised in the premises, makes these findings:

JURISDICTION

4. Each of the Defendants was duly and properly brought before the Court, through service of summons or proper service by publication, and due and proper notice was given to each of the defendants. This Court has jurisdiction over all the parties hereto and the subject matter presented herein.

EVIDENTIARY FINDINGS

5. The mortgaged real estate herein referred to is commonly known as 1000 East Woodfield, Schaumburg, Illinois (the “Real Estate”) and described in Exhibit 1 hereto.

6. The Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing attached as Exhibit 1 to the Complaint and hereby foreclosed was given by Mortgagor and recorded on February 1, 2006, and the amendment thereto was recorded on February 5, 2010, and appears of record in the office of the Recorder of Deeds of Cook County, Illinois, as Document Nos. 0603232046 and 1003618097 (collectively, the “Mortgage”). The Assignment of Rents and Leases (“Assignment of R&L”) attached as Exhibit 2 to the Complaint was recorded on February 2, 2006, and appears of record in the office of the Recorder of Deeds of Cook County, Illinois, as Document No. 060323047. The Promissory Note dated January 26, 2006, in the principal amount of \$15,757,00.00 (the “Note”) is attached as Exhibit 3 to the Complaint. The UCC-1 Financing Statement (the “Financing Statement”) attached as Exhibit 5 to the Complaint was recorded on February 1, 2006, and appears of record in the office of the Recorder of Deeds of Cook County, Illinois, as Document No. 060323048, as amended by Document No. 1003618099, and as continued by Document No. 1101234055.

7. Mortgagor is the present owner of the Real Estate.
8. Mortgagee is the holder of the Mortgage. Pursuant to 735 ILCS 5/15-1509.5,

Mortgagee's information is as follows:

9. The Mortgage hereby foreclosed and the lien of said Mortgage are governed by the provisions of Section 15-1101, et seq., of the IMFL, 735 ILCS 5/15 1101, et seq.

10. The rights and interests, if any, of all parties to this cause in and to the Real Estate are subject to, junior, subordinate and inferior to the lien of Mortgagee's Mortgage.

11. Pursuant to and in accordance with Section 15-1402 of the IMFL, 735 ILCS 5/15-1402, Mortgagee offered in Paragraph 15(s) of its Complaint to accept title to the Real Estate in satisfaction of all indebtedness and obligations secured by the Mortgage without judicial sale.

12. Notice of such offer has been given to all parties, who have not previously been found in default for failure to appear, answer or otherwise plead.

13. Pursuant to and in accordance with Section 15-1402 of the IMFL, 735 ILCS 5/15-1402, Mortgagor in its Answer and by Stipulation executed by Mortgagor and Mortgagee, has expressly consented to the entry of a judgment of foreclosure granting absolute title to the Real Estate in Mortgagee or its nominee free and clear of claims, liens and interests of Mortgagor, including waiving any and all rights to redeem the mortgaged premises whether by statute or in equity.

14. Pursuant to and in accordance with Section 15-1402 of the IMFL, 735 ILCS 5/15-1402, Mortgagee in its Complaint and by Stipulation executed by Mortgagor and Mortgagee, has offered and consented to entry of this judgment, and Mortgagee has waived its rights, if any, to a

personal judgment and/or deficiency judgment against Mortgagor and against all other persons liable for the indebtedness or other obligations secured by the mortgage (including without limitation any and all guarantors), which waiver shall become effective upon entry of this judgment from which no appeal is taken.

15. No party has objected to entry of such a judgment or paid the amount required to redeem.

ULTIMATE FINDINGS

16. The allegations of fact in the Complaint filed on June 7, 2012, including the "deemed" allegations as set forth in Section 15-1504(c) of the IMFL, 735 ILCS 5/15-1504(c), are deemed proved, including that an event of default exists as a result of Mortgagor's failure to pay the outstanding indebtedness due under the Note, for which the Mortgage serves as security, upon said Note's maturity. There is due to Mortgagee as of April 4, 2012, the sum of not less than \$15,860,954.23, for which sum Mortgagee has a valid, prior, paramount and superior lien on the Real Estate.

17. Mortgagee's Mortgage is prior and superior to all other mortgages, claims of interest and liens upon the Property.

18. Mortgagee is entitled to the relief requested in the Complaint.

IT IS, THEREFORE, ORDERED AND ADJUDGED:

A. Pursuant to 735 ILCS 5/15-1402 and 735 ILCS 5/15-1509(c), a judgment of consent foreclosure is granted to Mortgagee and against defendants and absolute title to the Real Estate described on Exhibit 1 hereto, together with all Improvements, as that term is defined in the Mortgage, and all easements and appurtenances belonging thereto, and all Rents and Leases as defined in the Mortgage and the Assignment of R&L, and all personal property as described in the

Mortgage and the Financing Statement, and all general intangibles and all accounts related to the Real Estate as described in the Mortgage, is hereby vested in Intervening Plaintiff 1000 East Woodfield Loan Holdings, LLC, a Delaware limited liability company, free and clear of any interest that Mortgagor holds in the Real Estate including all rights of reinstatement and redemption, which have been waived; free and clear of all recorded liens, claims and interests; and free and clear of the claims and interests of any Unknown Owners and Nonrecord Claimants.

B. Having waived its rights to a personal judgment and/or deficiency judgment, Mortgagee is barred from obtaining a personal judgment and/or deficiency judgment against Mortgagor and any other person liable for the indebtedness or other obligations secured by the Mortgage (including without limitation any and all guarantors).

C. Upon vesting of title by entry of this judgment, the Mortgagor and any and all Unknown Owners and Nonrecord Claimants, having been given notice of this foreclosure and all persons claiming by, through or under them, shall be forever barred and foreclosed of any rights, title, interest, claim, lien, or right to redeem in and to the Real Estate, and any part thereof or to object to this consent judgment.

D. Mortgagee or its assignee shall be entitled to possession of the Real Estate upon entry of this judgment, without notice to any defendant, further order of this Court or resort to proceedings under any statute.

E. This Judgment represents a transaction exempt under the provisions of 35 ILCS 31-45(l) of the Illinois Real Estate Transfer Tax Law and ¶ 74-106(13) of the Cook County Real Property Transfer Tax Ordinance, and the Cook County Recorder of Deeds is ordered to permit immediate recordation of this Judgment without any exemption stamps.



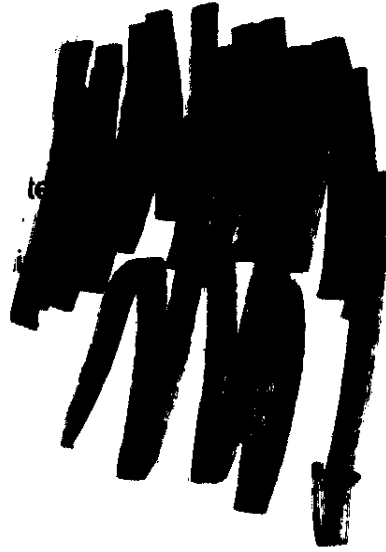
