**AMENDMENT TO
THE DECLARATION OF
RESTRICTIONS AND COVENANTS
FOR
GLEN ESTATES SUBDIVISION**

This document is recorded for the purpose of amending the Declaration of Restrictions and Covenants (hereafter the "Declaration"), for Glen Estates Subdivision (hereafter the "Association"), which Declaration was recorded on November 2, 1984, as Document No. 27321215 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article VIII, Section 5 of the aforesaid Declaration. Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by at least two-third (2/3) of the owners of all lots as such owners appear on record at 9:00 a.m. on the date thirty (30) days prior to the date of recording the amendment with the Recorder of Deeds of Cook County.

RECITALS

WHEREAS, the Board and the Owners desire to amend the Declaration in order to reduce the number of Board members to three (3); and

WHEREAS, the amendment has been executed by at least two-third (2/3) of the owners of all lots as such owners appear on record at 9:00 a.m. on the date thirty (30) days prior to the date of recording the amendment with the Recorder of Deeds of Cook County, all in compliance with Article VIII, Section 5 of the Declaration.

NOW THEREFORE, Article III, Section 5 of the Declaration of Restrictions and Covenants for Glen Estates Subdivision is hereby amended in accordance with the text which follows (additions in text are indicated by underline; deletions by ~~strike-outs~~):

5. ~~The Board of Directors of the Association shall be not less than five (5) nor more than fifteen (15) in number, which number shall be fixed from time to time by the Board of Directors at any meeting called for the purpose of changing the number thereof, by the affirmative vote of at least a majority of the Directors in office, and the number so fixed shall be the Board, regardless of vacancies, until the number of Directors is thereafter changed by similar action.~~ From and after the first annual meeting of the owners occurring after the date of recording of this amendment to the Declaration, the Board of Directors shall be three (3) in number. The Directors shall be elected at large by the members of the Association in accordance with the procedures set forth in the By-Laws.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
