## FIRST AMENDMENT TO DECLARATION FOR THE PRESERVES TOWNHOMES

**THIS FIRST AMENDMENT** to the Declaration for the Preserves Townhomes, recorded with the Cook County Recorder of Deeds on December 15, 1998 as Document No. 08136910, is made and entered into as of ~~the [REDACTED]~~ JUNE 11, 2012.

This document is recorded for the purpose of amending the Declaration for the Preserves Townhomes (the "Declaration"), as amended from time to time, for the property legally described as follows:

See attached Legal Description

This First Amendment is adopted pursuant to the provisions of Article Ten, paragraph 10.2 of the Declaration. Said section provides that the provisions of the Declaration may be amended upon approval by at least Seventy-Five percent (75%) of the Voting Members and that such amendment shall be effective upon recording of such instrument with the Cook County Recorder of Deeds.

WHEREAS, the Owners desire to amend the Declaration, subject to the terms and provisions of this First Amendment; and

WHEREAS, this First Amendment has been approved by at least Seventy-Five Percent (75%) of the Owners, in compliance with Article Ten;

NOW THEREFORE, the Declaration is hereby amended in accordance with the following terms and provisions:

A. ARTICLE ONE, Section 1.12 is revised to read as follows:

"1.12 HOME: That portion of a Parcel which is improved with a dwelling unit, including, but not limited to, the dwelling unit and its foundation, footings, sidewalks, steps, decks, patios and doors, including garage doors."

B. ARTICLE ONE, Section 1.13 is revised to read as follows:

"1.13 HOME EXTERIOR: The roof, gutters, downspouts and outer surface of exterior walls of a Home.

C. ARTICLE SEVEN, Section 7.07 is revised to read as follows:

“All costs and expenses incurred by the Board in connection with any action, proceedings or self-help in connection with exercise of its rights and remedies under this Article, including, without limitation, court costs, attorneys’ fees, property management fees and all other fees and expenses, and all damages, liquidated or otherwise, together with interest thereon at the rate of eighteen percent (18%) per annum or the maximum rate permitted by law, whichever is less, until paid, shall be charged to and assessed against the defaulting Owner, and the Association shall have a lien for all the same, upon his Parcel as provided in Section 7.01.”

D. The following section is added to ARTICLE EIGHT:

“8.10 LEASING: Subject to the provisions of this Section 8.10, any Owner shall have the right to lease his or her Home. All leases shall be in writing and it shall be the duty of the lessee to comply with the terms of the Association’s Declaration, By-Laws and Rules and Regulations; in no event, however, shall the absence of a provision in any such lease requiring the lessee to comply with the terms of the Declaration, By-Laws and/or Rules and Regulations excuse the lessee from complying with these documents and the failure to do so shall be a default under the lease notwithstanding the absence of a provision to that effect contained herein. All leases must be submitted to the Board immediately following execution of the lease. Furthermore:

1. Lessee’s rights within the Association are subordinate to those rights of all other Association members and will be considered by the Board only as presented by the lessee’s respective Owner - lessor.

2. Not more than ten percent (10%) of the Association’s total number of Homes may be leased at any one time. Owners’ requests for approval to lease that are in excess of the 10% restriction shall be placed on a waiting list based on the date of the Owner’s written request to the management company and considered by the Board as lease approval becomes available. An Owner must lease his or her Home within three (3) months of the Board’s notice to that Owner of the Board’s approval to lease. If the Owner does not lease the Home within the three month period, the approval shall expire and the next Owner request will be considered. Once approved by the Board for lease, the continuance of the Board’s approval to that specific Owner to lease shall remain in effect from one approved lessee to another approved lessee. Continued Board approval of the present or future lessees for a Home may be revoked at the sole discretion of the Board if either the Owner or a lessee fails to abide by any governing instrument(s) of the Association. In the event of Board revocation, the Owner must submit another written request to lease to the management company which will be considered after any other, on file, Owner’s written request to lease. The Board’s approval to lease shall expire three months from any vacancy, abandonment or failure to lease. In the event of the Owner’s sale of the Home, the Board’s approval to lease shall terminate effective the date of the sale and shall not continue in effect for the subsequent Owner.

3. An Owner must provide 30 days' written request to the management company of their request to lease their Home. In any instance described herein, the Owner must provide a fully completed and signed lease application, contingent upon approval by the Board, which includes the potential lessee's name, current address and phone number, date of birth, employment information (including address and phone number) and current landlord's name and contact information (if applicable).

4. All leases must be for a minimum of one year. All leases must expressly state that lessees are subject to the Association's Declaration and By-Laws and all Rules and regulations adopted by the Board. Owners are required to provide the potential lessee(s) with a copy of the Association's Declarations, By-laws, Rules and Regulations and any resolutions or policies that are published, at least seven (7) calendar days prior to the signing of the lease with a written, signed and dated acknowledgement of receipt of these instruments by the lessee(s). A copy of this acknowledgement must be tendered to the Board.

5. The number of residents may not exceed the limits as set forth by Orland Park Village Ordinances.

6. Present Owners' lessee(s) are grandfathered as approved as are any continuations of future leases to these specific lessee(s), except if there is any lapse in any lease to these grandfathered lessee(s) whereby this will then necessitate full and complete Owner compliance with the provisions of this section of the Declaration.

7. Owners are responsible for any damages or any nuisance created by the lessee, their family, their visitors, their contractors or any delivery or other service companies as they relate to the lessee(s), the Home or any Community Areas of the Association.

8. Violations: Any Owner found to be in any violation of the provisions of this section of the Declaration may be fined as follows:

(a) \$1,000.00 for failure to provide a prior written request to lease, application documents, follow application process or failure to abide with this specific resolution, and

(b) Failure to provide the required lease documents after the 14<sup>th</sup> day of possession may result in a \$1,000.00 fine and an additional \$25.00 per day fine until all necessary documents have been received by the management company.

E. Except to the extent that they conflict with the amendatory language set forth above, the remaining provisions of the Declaration shall continue in effect without change.

As evidence of agreement and consent to the foregoing, the Owners hereby attach their signatures.
