Any election to terminate the condominium project after substantial destruction or substantial taking by condemnation of the Property shall require the approval of at least 51% of the Unit Owners and the Eligible First Mortgagees of the Units that represent at least 51% of the Units subject to a mortgage held by an Eligible First Mortgagee.
