That on <u>July 2, 2012</u>, the Village of East Hazel Crest caused said weeds to be cut, removed and destroyed, and the reasonable cost and expenses incurred for the work was <u>Ninety and no/100</u> Dollars (\$90.00), and that said sum remains unpaid.
